W H E R E A S:


A) Akhil Kumar Naskar was seized and possessed of and/or otherwise well and sufficiently entitled to All That the piece and parcel of land containing an area of 88 (eighty eight) decimal, be the same a little more or less, lying situate at Mouza Sarmasterchak, J.L. No.17, R.S. *Dag* No.117 corresponding to L.R. *Dag* No.116, R.S. *Khatian* No.77, Police Station Bishnupur, within Kulerdari *Gram Panchayet*, District South 24 Parganas (hereinafter referred to as the **said entire land**).

E) By a Deed of Conveyance dated the 4th day of May, 2001, made between the said Kabita Biswas therein referred to as the Vendor of the one part and Ashutosh Mukhopadhyay therein referred to as the Purchaser of the other part and the Vendor herein and registered in the Office of the Additional District Sub-Registrar, Bishnupur, South 24-Parganas, in Book No. 1, Volume No.71, at Pages 373 to 384, Being No.3788 for the year 2006, the Vendor therein for the consideration therein mentioned, granted transferred conveyed assigned and assured unto and in favour of the Purchaser therein All That the First part of said land.

F) By virtue of the aforesaid purchases the Vendor herein became the absolute owner of All That the First part of said land and Second part of said land (hereinafter jointly referred to as the **said land**).
