No. - 32, Police Station Rajarhat, within the limits of Rajarhat Bishnupur 2 No *Gram Panchayat*, District North 24 Parganas (collectively **Abdul Rashid's Property**).

5.1.3 **Record of Right:** Abdul Rashid Dhali mutated his name, in the records of Land Revenue Settlement vide L. R. *Khatian* No. 1054, as owner of Abdul Rashid's Property.

5.1.4 **Absolute Ownership of Said Property:** In the abovementioned circumstances, the Vendor has become the undisputed owner of the Said Property.




