- a) in Form "E" not less than seven days before commencement of the work U/R 28.
 - b) in Form "F" after completion of work up to the plinth level or up to one metre above 9 round level, which ever is higher U/R 29.
 - c) in Form "G" after completion of erection of building / execution of work U/R 33 (copy of Form E.F.G. enclosed for reference)
2. Occupancy Certificate in Form "H" U/R 34 can be issued only after receipt of notice of completion of work from the owner, and satisfactory report thereto by authorised Municipal Officer.
3. Occupancy of the building without Occupancy Certificate is prohibited U/S 212 (2) of the Act, read with Rule 36.
