Said M/s Balaji Steel Casting Ltd., became sick and its case was referred to board of industrial and financial reconstruction (BIFR) and the BIFR passed an order dated 27th January ,1994 recommending winding up of the Company of the Said M/s Balaji Steel Casting Ltd., and forwarded the said Recommendation to the High Court; Calcutta BIFR further passed an order dated 09.02.1994 inter alia, appointing the WEST BENGAL INDUSTRIAL DEVELOPMENT CORPORATION LIMITED (WBIDC) to dispose of the assets of the Said M/s Balaji Steel Casting Ltd., in terms of Sub Section 4 of Section 20 of sick industrial companies (Special provisions) Act, 1985 laying down the procedure for sale of assets including handling over possession of the assets and transfer of title to the intending purchaser by the said WEST BENGAL INDUSTRIAL DEVELOPMENT CORPORATION LIMITED (WBIDC).
