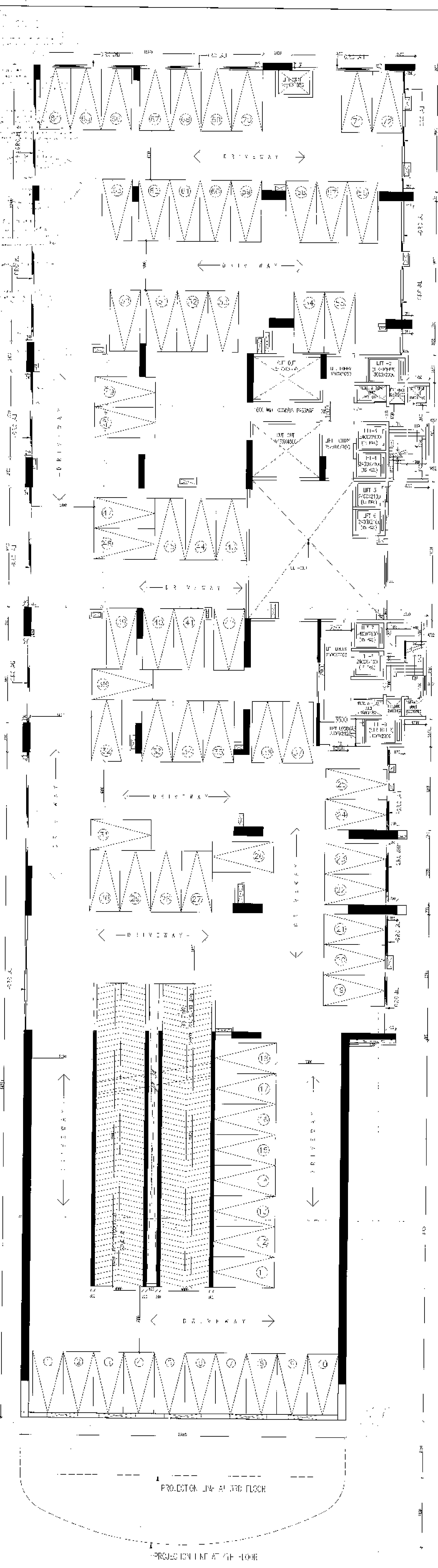


1ST FLOOR PLAN
