- 3. That details of encumbrances with Tata Capital Housing Finance Limited amounting to Rs 22 crores is enclosed herewith.
- 4. That the time period within which the project shall be completed by the promoter is 30.06.2021 (Project Completion Date).
- 4. That seventy per cent of the amounts realised by promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
