1. The agreement is supplemental to the Deed of Partnership dated 17th February, 2010 and made between the said Md. Nasim Khan, S/o. Md. Muslim Khan and Sri Monoj Choudhury, S/o. Surendra Choudhury.
2. As from the date hereof the said Smt. Papiya Mukherjee W/o. Sri Pintu Mukherjee shall be a partner with the said Md. Nasim Khan, S/o. Md. Muslim Khan and Sri Monoj Choudhury, S/o. Surendra Choudhury for the unexpired residue of the term created by and subject in all respect to the conditions, stipulations and provisions of the said deed of 17th Feb., 2010 except in so far as the same are varied by this agreement.
3. The capital of the partnership shall be the sum of Rs. 3,00,000/- (Rupees Three lac only) contributed by the parties hereto in equal one-third shares.
4. The said Smt. Papiya Mukherjee has paid on the date hereof the sum of Rs. 1,00,000/- (Rupees One lac only) as capital of the partnership.
