5.1.3 **Demise of Abdul Alim Molla *alias* Alim Molla *alias* Alim Mandal:** On or about 24th January, 2013, Abdul Alim Molla *alias* Alim Molla *alias* Alim Mandal, a Muslim governed by the *Sunni* School of Mohammedan law, died *intestate*, leaving behind him surviving his only wife, Anowara Bibi *alias* Anwara Bibi (the Vendor No.3.1 herein), his 2 (two) sons, namely, (1) Ajijul Islam *alias* Azizul Islam (the Vendor No.3.2 herein) and (2) Safikul Islam *alias* Safiqul Islam (the Vendor No.3.3 herein) and his only married daughter, Rokeya Bibi *alias* Rokeya Khatun (the Vendor No.3.4 herein), as his only legal heiresses and heirs, who jointly and in diverse shares inherited the right, title and interest of Late Abdul Alim Molla *alias* Alim Molla *alias* Alim Mandal in the Said Property.

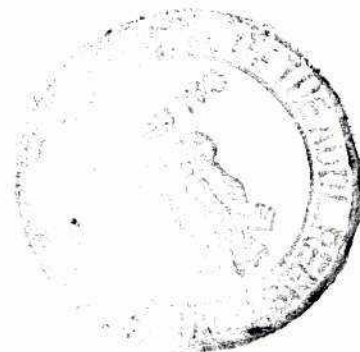

- 8.1.4 **Together with All Other Appurtenances:** together with all other rights the Vendors have in the Said Property and all other appurtenances including but not limited to customary and other rights of easements for beneficial use of the Said Property.
- 8.2 **Subject to:** The transfer being effected by this Conveyance is subject to:
- 8.2.1 **Indemnification by Vendors:** express indemnification by the Vendors about the correctness of the Vendors' title, Vendors' authority to sell and non existence of any encumbrances on the Said Property, which if found defective or untrue at any time, the Vendors shall, at all times hereafter, at the costs, expenses, risk and responsibility of the Vendors, forthwith take all necessary steps to remove and/or rectify.
