- 5.1.3 Ownership of Arabinda Nath: After the demise of Subodh Bala Nath, Arabinda Nath became the sole and absolute owner of the Arabinda Nath's Share.

- 5.1.5 Purchase by Vendor: By a Deed of Conveyance dated 1" October, 2010, registered in the Office of the District Sub-Registrar-II, Barasat, North 24 Parganas, in Book No. I, CD Volume No. 40, at Pages 2084 to 2098, being Deed No.11559 for the year 2010, the Vendor purchased the entirety of Arabinda Nath's Share from Sumitra Devi Verma, for the consideration mentioned therein. The Said Property is a part of Arabinda Nath's Share and is the subject matter of this Conveyance.
- 5.1.6 Absolute Ownership of Vendor: In the abovementioned circumstances, the Vendor has become the sole and absolute owner of the Said Property.
- 5.2 Representations, Warranties and Covenants Regarding Encumbrances: The Vendor represents and warrants to and covenants with the Purchaser regarding encumbrances as follows:


