

- 4. Subject Matter of Conveyance

Dag No. 496, recorded in L.R. Khahan Nos.1754 and 1755, Mouza Bhatenda, J.L. No. 28, Police Station Rajarhat, within the jurisdiction of Rajarhat-Bishnupur No. 1 Gram Panchayet (RBGP), Sub-Registration District Bidhannagar, District North 24 Parganas and more fully described in the Schedule below and the said Dag No. 496 is delineated and demarcated on the Plan annexed hereto and bordered in colour Red thereon (Said Property) together with all title, benefits, casements, authorities, claims, demands, usufructs, tangible and intangible rights of whatsoever or howsoever nature of the Vendors in the Said Property and appurtenances and inheritances for access and user thereof.

6.2Surrender/Transfer of Rights: R.S. 
