Raushanara Khatun jointly sold, conveyed and transferred land classified as sali (agricultural) measuring 8.4520 (eight point four five two zero) decimal equivalent to 5 (five) cottah 1 (one) chittack and 37 (thirty seven) square feet, more or less together with right of easement and user over a 14' (fourteen feet) wide common passage, being defined as the Said Property in Clause 4.1 above, out of the Mother Land to Krishnapada Mahalnabish, for the consideration mentioned therein.

- 5.1.3 Purchase by Vendors: By a Deed of Sale in Bengali language (Kobala) dated 16<sup>th</sup> August, 2002, registered in the Office of the Additional District Sub-Registrar, Bidhannagar, Salt Lake City, North 24 Parganas, in Book No. I, Volume No. 128, at Pages 38 to 51, being Deed No.02202 for the year 2003, Krishnapada Mahalnabish sold, conveyed and transferred the Said Property to the Vendors, for the consideration mentioned therein.


