- 5.1.4 Purchase by Vendor: By a Deed of Sale in Bengali language (Kobala) dated 16th June, 2004, registered in the Office of the Additional District Sub-Registrar, Bidhannagar, Salt Lake City, North 24 Parganas, in Book No. I, Volume No. 226, at Pages 1 to 11, being Deed No.3702 for the year 2006, the Vendor purchased the entirety of the Said Property from Debashish Mondal, for the consideration mentioned therein.
- 5.1.5 Absolute Ownership of Vendor: In the abovementioned circumstances, the Vendor has become the sole and absolute owner of the Said Property.
- 5.2 Representations, Warranties and Covenants Regarding Encumbrances: The Vendor represents and warrants to and covenants with the Purchaser regarding encumbrances as follows:

### 6. Basic Understanding

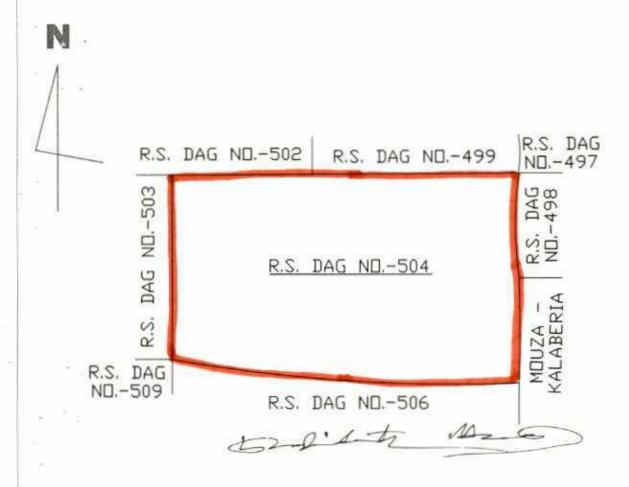

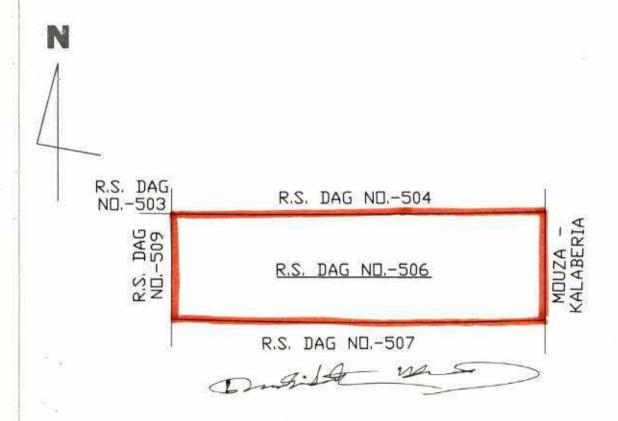

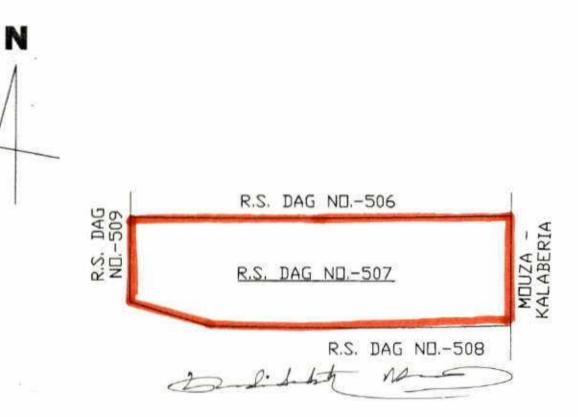
