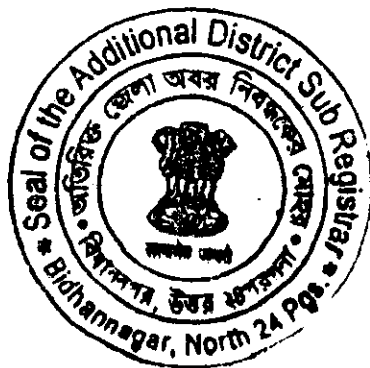
6. **Basic Understanding :**
