5. Background, Representations, Warranties and Covenants

- 5.1 **Representations and Warranties Regarding Title:** The Vendor has made the following representations and given the following warranties to the Purchasers regarding title:

5.1.1 **Purchase of Mother Property:** By a Deed of Conveyance in Bengali Language (*Kobala*) dated 23rd February, 1954, registered in the Office of the Sub-Registrar, Baruipur, in Book No. I, Volume No. 19, at Pages 175 to 179, being Deed No. 719 for the year 1954, Fakir Chandra Sardar, Bankim Chandra Sardar (the Vendor herein) and Brihaspati Dasi jointly purchased from Sundari Dasi *inter alia sali* (agricultural) land measuring 38 (thirty eight) decimal, more or less, being the entire R.S./L.R. Dag No. 8, recorded in R.S. *Khatian* No. 261, *Mouza* Khas Mallick, J.L. No. 35, Police Station Baruipur, Sub-Registration District Baruipur, District 24 Parganas (**Mother Property**), free from all encumbrances and for the consideration mentioned therein. Thus, Fakir Chandra Sardar, Bankim Chandra Sardar (the Vendor herein) and Brihaspati Dasi became the joint and absolute owners of the Mother Property each having an undivided 1/3rd (one third) share and/or interest therein.

5.1.2 **Demise of Brihaspati Dasi:** Brihaspati Dasi, a Hindu, governed by the *Dayabhaga* School of Hindu Law, died intestate (her husband having predeceased her), leaving behind her surviving her 2 (two) sons, namely, Fakir Chandra Sardar and Bankim Chandra Sardar (the Vendor herein) and 2 (two) daughters, namely, Nanda Bala Dasi and Khanda Bala Dalui, as her only legal heirs and heiresses, who jointly and in equal shares inherited the right, title and interest of Late Brihaspati Dasi in the Mother Property.

5.1.3 **Ownership of Legal Heirs of Brihaspati Dasi:** Thus, by virtue of the purchase and inheritance as aforesaid, the legal heirs of Late Brihaspati Dasi became the joint owners of the Mother Property having the following shares:

5.1.4 **Sale by Khanda Bala Dalui:** By a Deed of Conveyance in Bengali Language (*Kobala*) dated 7th August, 1975, registered in the Office of the Sub-Registrar, Baruipur, in Book No. I, Volume No. 80, at Pages 113 to 119, being Deed No. 6878 for the year 1975, Khanda Bala Dalui sold, conveyed and transferred *inter alia* Khanda Bala's Share In Dag No. 8 to Bankim Chandra Sardar (the Vendor herein), free from all encumbrances and for the considerations mentioned therein.

5.1.5 **Ownership of Vendor's Property:** By virtue of the purchases and inheritance as aforesaid, the Vendor became the absolute owner of Bankim's Share In Dag No. 8 and Khanda Bala's Share In Dag No. 8 (collectively **Vendor's Property**).

- 5.1.6 **Sale to Fakir Chandra Sardar:** By a Deed of Conveyance in Bengali Language (*Kobala*) dated 21st February, 1979, registered in the Office of the Sub-Registrar, Baruipur, in Book No. I, Volume No. 24, at Pages 22 to 25, being Deed No. 1087 for the year 1979, the Vendor sold, conveyed and transferred to Fakir Chandra Sardar land measuring 4 (four) decimal, being a portion of the Vendor's Property, free from all encumbrances and for the considerations mentioned therein.
- 5.1.7 **Ownership of Balance Of Vendor's Property:** In the above circumstances, the Vendor became the absolute owner of the remaining land measuring 15 (fifteen) decimal out of the Vendor's Property (**Balance Of Vendor's Property**). Although the measurement of Balance Of Vendor's Property was 15 (fifteen) decimal, pursuant to the acquisition as aforesaid, the Vendor was recorded as the *rayat* of only 8 (eight) decimal in respect of R.S. *Dag* No. 8 in L.R. *Khatian* No. 345, which the Said Property herein and is the subject matter of this Deed of Conveyance.
- 5.1.8 **Absolute Ownership of Vendor:** In the aforesaid circumstances, the Vendor has become the undisputed and absolute owner of the Said Property, free from all encumbrances.
- 5.2 **Representations, Warranties and Covenants Regarding Encumbrances:** The Vendor represents, warrants and covenants regarding encumbrances as follows:
- 5.2.1 **No Acquisition/Requisition:** The Vendor has not received any notice from any authority for acquisition, requisition or vesting of the Said Property and declares that the Said Property is not affected by any scheme of the *Panchayet* Authority or Government or any Statutory Body.
- 5.2.2 **No Excess Land:** The Vendor does not hold any excess vacant land under the Urban Land (Ceiling and Regulation) Act, 1976 or any excess land under the West Bengal Land Reforms Act, 1955 or the West Bengal Estates Acquisition Act, 1953.

- 5.2.4 **Right, Power and Authority to Sell:** The Vendor has good right, full power, absolute authority and indefeasible title to grant, sell, convey, transfer, assign and assure the Said Property to the Purchasers.
- 5.2.5 **No Dues:** No tax in respect of the Said Property is due to the local authority and/or any other authority or authorities and no Certificate Case is pending for realization of any dues from the Vendor.
- 5.2.6 **No Right of Pre-emption:** No person or persons whatsoever have/had/has any right of pre-emption over and in respect of the Said Property or any part thereof.

6. Basic Understanding

No. 35, Police Station Baruipur, within the jurisdiction of HGP, Sub-Registration District Baruipur, District South 24 Parganas and the said R.S./L.R. *Dag* No. 8 being delineated and demarcated on the **Plan** annexed hereto and bordered in colour **Red** thereon **together with** all title, benefits, easements, authorities, claims, demands, usufructs, tangible and intangible rights of whatsoever or howsoever nature of the Vendors in the Said Property and appurtenances and inheritances for access and user thereof, free from all encumbrances.
- 7.2 **Total Consideration:** The aforesaid transfer is being made in consideration of a sum of Rs.19,35,806/- (Rupees nineteen lac thirty five thousand eight hundred and six) paid by the Purchasers to the Vendor, receipt of which the Vendor hereby as well as by the Receipt and Memo of Consideration hereunder written, admits and acknowledges.

8. Terms of Transfer

8.1 **Salient Terms:** The transfer being effected by this Conveyance is:

8.1.1 **Sale:** a sale within the meaning of the Transfer of Property Act, 1882.

8.1.2 **Absolute:** absolute, irreversible and perpetual.

8.1.3 **Free from Encumbrances:** free from all claims, demands, encumbrances, mortgages, charges, liens, attachments, lis pendens, uses, *debutters*, trusts, prohibitions, Income Tax attachments, financial institution charges, statutory prohibitions, acquisitions, requisitions, vestings, *bargadars* and liabilities whatsoever or howsoever made or suffered by the Vendor or any person or persons having or lawfully, rightfully or equitably claiming any estate or interest therein through, under or in trust for the Vendor or the Vendor's predecessors-in-title.

8.1.4 **Together with All Other Appurtenances:** together with all other rights the Vendor has in the Said Property and all other appurtenances including but not limited to customary and other rights of easements for beneficial use of the Said Property.

8.2 **Subject to:** The transfer being effected by this Conveyance is subject to:

8.2.1 **Indemnification:** Indemnification by the Vendor about the correctness of the Vendor's title and authority to sell and this Conveyance is being accepted by the Purchasers on such express indemnification by the Vendor about the correctness of the Vendor's title, which if found defective or untrue at any time, the Vendor shall, at the costs, expenses, risk and responsibility of the Vendor, forthwith take all necessary steps to remove and/or rectify.

8.2.2 **Transfer of Property Act:** All obligations and duties of vendor and vendee as provided in the Transfer of Property Act, 1882, save as contracted to the contrary hereunder.

8.3 **Delivery of Possession:** *Khas*, vacant peaceful and physical possession of the Said Property have been handed over by the Vendor to the Purchasers.

8.4 **Outgoings** All statutory revenue, cess, taxes, surcharge, outgoings and levies of or on the Said Property, relating to the period till the date of this Conveyance, whether as yet demanded or not, shall be borne, paid and discharged by the Vendor, with regard to which the Vendor hereby indemnifies and agrees to keep the Purchasers fully and comprehensively saved, harmless and indemnified.

8.5 **Holding Possession:** The Vendor hereby covenants that the Purchasers and their successors-in-interest and assigns shall and may, from time to time, and at all times hereafter, peacefully and quietly enter into, hold, possess, use and enjoy the Said Property and every part thereof and receive rents, issues and profits thereof and all other benefits, rights and properties hereby granted, sold, conveyed, transferred, assigned and assured or expressed or intended so to be unto and to the Purchasers, without any lawful eviction, hindrance, interruption, disturbance, claim or demand whatsoever from or by the Vendor or any person or persons lawfully or equitably claiming any right or estate therein from under or in trust from the Vendor.

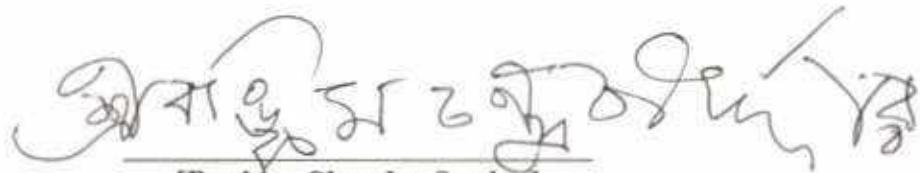

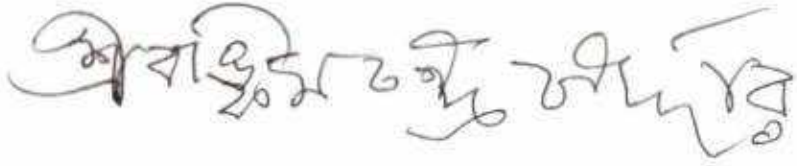

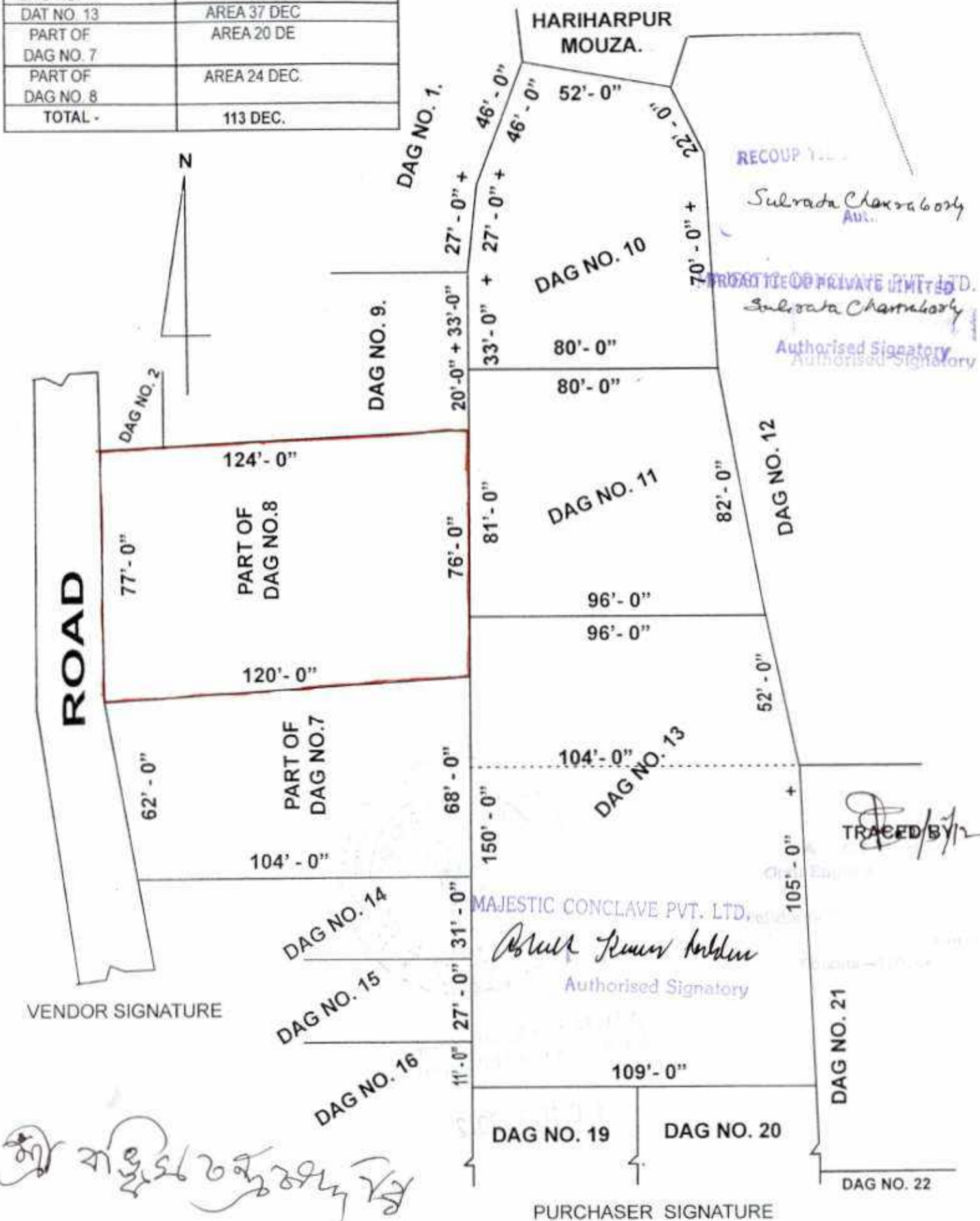
SITE PLAN
