No. 35, Police Station Baruipur, within the jurisdiction of Hariharpur *Gram Panchayet* (**HGP**), Sub-Registration District Baruipur, District South 24 Parganas more fully described in the **Schedule** below and the said R.S./L.R. *Dag* No. 20 being delineated and demarcated on the **Plan** annexed hereto and bordered

## 5. Background, Representations, Warranties and Covenants

5.1 **Representations and Warranties Regarding Title:** The Vendor has made the following representations and given the following warranties to the Purchasers regarding title:

5.1.1 **Ownership of Balai Chandra Das:** Balai Chandra Das was the recorded owner of *danga* (highland) land measuring 30 (thirty) decimal, more or less, comprised in R.S./L.R. *Dag* No. 20, recorded in L.R. *Khatian* No. 1432, *Mouza* Khas Mallick, J.L. 5.1.2 **Gift by Balai Chandra Das:** By a Deed of Gift in Bengali Language (*Daanpatra*) dated 13<sup>th</sup> April, 2007, registered in the Office of the Additional District Sub-Registrar, Baruipur, in Book No. I, being Deed No. 1102 for the year 2007, Balai Chandra Das, out of natural love and affection, unconditionally gifted the Mother Property to his 2 (two) sons, namely, Sujit Das and Amit Das and his grandson, Chiranjit Das, free from all encumbrances.

5.1.3 **Mutation:** Sujit Das and Chiranjit Das had got their names mutated in the records of the Block Land And Land Reforms Office, Baruipur in L.R. *Khatian* Nos. 1449 and 1448, respectively, with regard to their shares in the Mother Property, which shares are collectively the Said Property and is the subject matter of this Conveyance.

5.1.4 **Purchase by Vendor:** By a Deed of Conveyance dated 2<sup>nd</sup> March, 2011, registered in the Office of District Sub Registrar IV, Alipore, in Book No. I, CD Volume No. 6, at Pages 736 to 749, being Deed No. 1568 for the year 2011, the Vendor purchased the entirety of the Said Property out of the Mother Property from Sujit Das and Chiranjit Das, free from all encumbrances and for the consideration mentioned therein.

5.1.5 **Absolute Ownership of Vendor:** In the aforesaid circumstances, the Vendor has become the undisputed and absolute owner of the Said Property, free from all encumbrances.

5.2 **Representations, Warranties and Covenants Regarding Encumbrances:** The Vendor represents, warrants and covenants regarding encumbrances as follows:

5.2.1 **No Acquisition/Requisition:** The Vendor has not received any notice from any authority for acquisition, requisition or vesting of the Said Property and declares that the Said Property is not affected by any scheme of the *Panchayet* Authority or Government or any Statutory Body.

5.2.2 **No Excess Land:** The Vendor does not hold any excess vacant land under the Urban Land (Ceiling and Regulation) Act, 1976 or any excess land under the West Bengal Land Reforms Act, 1955 or the West Bengal Estates Acquisition Act, 1953.

5.2.3 **No Encumbrance by Act of Vendor:** The Vendor has not at any time done or executed or knowingly suffered or been party or privy to any act, deed, matter or

thing, including grant of right of easement, whereby the Said Property or any part thereof can or may be impeached, encumbered or affected in title.

- 5.2.4 **Right, Power and Authority to Sell:** The Vendor has good right, full power, absolute authority and indefeasible title to grant, sell, convey, transfer, assign and assure the Said Property to the Purchasers. In a meeting dated 20<sup>th</sup> April, 2012, the Board of Directors of the Vendor adopted a resolution to the effect that Tamal Bhattacharjee, Director, be authorized to sell *inter alia* the Said Property on such terms and conditions and in such manner as Tamal Bhattacharjee, Director, may consider beneficial and convenient for the Vendor. - 5.2.7 **No Mortgage:** No mortgage or charge has been created by the Vendor by depositing the title deeds or otherwise over and in respect of the Said Property or any part thereof.
