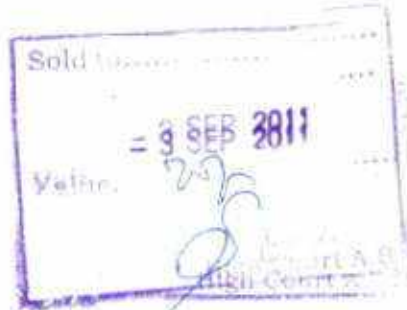

## 5. Background, Representations, Warranties and Covenants

5.1 **Representations and Warranties Regarding Title:** The Vendor has made the following representations and given the following warranties to the Purchasers regarding title:

5.1.1 **Purchase of Mother Property:** By a Deed of Conveyance in Bengali Language (*Kobala*) dated 4<sup>th</sup> March, 1959, registered in the Office of the Sub-Registrar, Baruipur, in Book No. I, Volume No. 35, at Pages 16 to 18, being Deed No. 1682 for the year 1959, Amulya Ratan Das purchased *sali* (agricultural) land measuring 29 (twenty nine) decimal, comprised in R.S./L.R. *Dag* No. 88, recorded in R.S. *Khatian* No. 181, *Mouza* Hariharpur, J.L. No. 11, Police Station Baruipur, Sub-Registration District Baruipur, District 24 Parganas (**Mother Property**), from Haripada Mondal, Kalipada Mondal, Naran Mondal, Rabiram Mondal and Sailabala Dasi, free from all encumbrances and for the consideration mentioned therein.

5.1.2 **Ownership of Amulya Ratan Das:** In the above circumstances, Amulya Ratan Das became the sole and absolute owner of the Mother Property and got his name mutated in the records of the Block Land And Land Reforms Office, Baruipur in L.R. *Khatian* No. 1338, in respect thereof.

5.1.3 **Demise of Amulya Ratan Das:** Amulya Ratan Das, a Hindu, governed by the *Dayabhaga* School of Hindu Law, died *intestate* leaving behind him surviving his 2 (two) sons, namely, Maniklal Das and Swapan Kumar Das, as his only legal heirs, who jointly and in equal shares inherited the right, title and interest of Late Amulya Ratan Das in the Mother Property. The Said Property is a portion of Mother Property and is also the subject matter of this conveyance.

5.1.4 **Purchase by Vendor:** By a Deed of Conveyance dated 6<sup>th</sup> July, 2011, registered in the Office of the District Sub-Registrar IV, Alipore, in Book No. I, CD Volume No. 17, at Pages 1428 to 1442, being Deed No. 5048 for the year 2011, the Vendor purchased the entirety of the Said Property out of the Mother Property from Maniklal Das and Swapan Kumar Das, free from all encumbrances and for the consideration mentioned therein.

5.1.5 **Absolute Ownership of Vendor:** In the aforesaid circumstances, the Vendor has become the undisputed and absolute owner of the Said Property, free from all encumbrances.

5.2 **Representations, Warranties and Covenants Regarding Encumbrances:** The Vendor represents, warrants and covenants regarding encumbrances as follows:

5.2.1 **No Acquisition/Requisition:** The Vendor has not received any notice from any authority for acquisition, requisition or vesting of the Said Property and declares that the Said Property is not affected by any scheme of the *Panchayet* Authority or Government or any Statutory Body.

5.2.2 **No Excess Land:** The Vendor does not hold any excess vacant land under the Urban Land (Ceiling and Regulation) Act, 1976 or any excess land under the West Bengal Land Reforms Act, 1955 or the West Bengal Estates Acquisition Act, 1953.

- 5.2.3 **No Encumbrance by Act of Vendor:** The Vendor has not at any time done or executed or knowingly suffered or been party or privy to any act, deed, matter or thing, including grant of right of easement, whereby the Said Property or any part thereof can or may be impeached, encumbered or affected in title.
- 5.2.4 **Right, Power and Authority to Sell:** The Vendor has good right, full power, absolute authority and indefeasible title to grant, sell, convey, transfer, assign and assure the Said Property to the Purchasers. In a meeting dated 20<sup>th</sup> April, 2012, the Board of Directors of the Vendor adopted a resolution to the effect that Tamal Bhattacharjee, Director, be authorized to sell *inter alia* the Said Property on such terms and conditions and in such manner as Tamal Bhattacharjee, Director, may consider beneficial and convenient for the Vendor. Tamal Bhattacharjee, has been authorized and empowered by the Vendor to sign this Conveyance upon observance of all due process of law and is thus competent and lawfully authorized to execute this Conveyance on behalf of the Vendor.
- 5.2.5 **No Dues:** No tax in respect of the Said Property is due to the local authority and/or any other authority or authorities and no Certificate Case is pending for realization of any dues from the Vendor.
- 5.2.6 **No Right of Pre-emption:** No person or persons whatsoever have/had/has any right of pre-emption over and in respect of the Said Property or any part thereof.
- 5.2.7 **No Mortgage:** No mortgage or charge has been created by the Vendor by depositing the title deeds or otherwise over and in respect of the Said Property or any part thereof.
- 5.2.8 **Free From All Encumbrances:** The Said Property is now free from all claims, demands, encumbrances, mortgages, charges, liens, attachments, *in pendens*, *uses*, *debentures*, trusts, prohibitions, Income Tax attachments, financial institution charges, statutory prohibitions, acquisitions, requisitions, vestings, *bargadars* and liabilities whatsoever or howsoever made or suffered by the Vendor or any person or persons having or lawfully, rightfully or equitably claiming any estate or interest therein through, under or in trust for the Vendor or the Vendor's predecessors-in-title and the title of the Vendor to the Said Property is free, clear and marketable.
- 5.2.9 **No Corporate Guarantee:** The Said Property is not affected by or subject to any corporate guarantee for securing any financial accommodation.
- 5.2.10 **No Bar by Court Order or Statutory Authority:** There is no order of Court or any other statutory authority prohibiting the Vendor from selling, transferring and/or alienating the Said Property or any part thereof.




