4. Subject Matter of Conveyance

- 5.1.2 **Demise of Swarnamoyee Debi:** Swarnamoyee Debi a Hindu, governed by the *Dayabhaga* School of Hindu Law, died *intestate* leaving behind her surviving her only son, Madhusudan Bandyopadhyay, and her 3 (three) daughters, namely, Hemlata Mukherjee, Sefali Chatterjee and Kusum Mukherjee, as her only legal heir and heiresses, who jointly and in equal shares inherited the right, title and interest of Late Swarnamoyee Debi in the Mother Property.
- 5.1.3 **Demise of Madhusudan Bandyopadhyay:** Madhusudan Bandyopadhyay a Hindu bachelor, governed by the *Dayabhaga* School of Hindu Law, died *intestate* leaving behind him surviving his 3 (three) sisters, namely, Hemlata Mukherjee, Sefali Chatterjee and Kusum Mukherjee, as his only legal heiresses, who jointly and in equal shares inherited the right, title and interest of Late Madhusudan

Thus, in the above circumstances Hemlata Mukherjee became the owner of Hemlata's Property, Sefali Chatterjee became the owner of Sefali's Property and Kusum Mukherjee became the owner of Kusum's Property.

5.1.4 **Record of Rights:** Although after the demise of Madhusudan Bandyopadhyay, Hemlata Mukherjee, Sefali Chatterjee and Kusum Mukherjee became the joint owners of the Mother Property, each having an undivided $1/3^{\text{rd}}$ (one third share) and/or interest therein, at time of recording in the Land Revenue Settlement, the entirety of the Mother Property was erroneously recorded in the name of Hemlata Mukherjee in L.R *Khatian* No. 627.

5.1.5 **Demise of Hemlata Mukherjee:** Hemlata Mukherjee a Hindu, governed by the *Dayabhaga* School of Hindu Law, died *intestate* [her husband having predeceased her] leaving behind her surviving her only son, Panchanan Mukherjee, as her only legal heir, who inherited the right, title and interest of Late Hemlata Mukherjee in Hemlata's Property, solely and absolutely.

5.1.6 **Demise of Panchanan Mukherjee:** Panchanan Mukherjee, a Hindu, governed by the *Dayabhaga* School of Hindu Law died issueless and *intestate* [his wife having predeceased him] leaving behind him surviving his aunts, Sefali Chatterjee and Kusum Mukherjee, as his only legal heiresses, who jointly and in equal shares inherited the right, title and interest of Late Panchanan Mukherjee in Hemlata's Property. Thus, now, the share in the Mother Property came to be as follows:

- 5.1.8 **Demise of Sefali Chatterjee:** On or about 25th July, 1996, Sefali Chatterjee, a Hindu, governed by the *Dnyabhaga* School of Hindu Law, died intestate, leaving behind her surviving her 3 (three) sons, namely, Sisir Kumar Chatterjee, Sarat Chandra Chatterjee and Provat Kumar Chatterjee as her only legal heirs, who jointly and in equal shares inherited the right, title and interest of Late Sefali Chatterjee in the Said Property.
- 5.1.9 **Demise of Sisir Kumar Chatterjee:** On or about 30th June, 2006, Sisir Kumar Chatterjee, a Hindu, governed by the *Dnyabhaga* School of Hindu Law, died intestate, leaving behind him surviving his wife, Sarbani Chatterjee and only daughter, Baisakhi Chatterjee as his only legal heiresses, who jointly and in equal shares inherited the right, title and interest of Late Sisir Kumar Chatterjee in the Said Property.
- 5.1.10 **Sale to Dinabandhu Naskar:** By a Deed of Conveyance in Bengali Language (*Kobala*) dated 14th January, 2011, registered in the Office of the Additional District Sub Registrar, Baruipur, in Book No. 1, CD Volume No. 1, at Pages 3082 to 3092, being Deed No. 247 for the year 2011, Sarat Chandra Chatterjee, Provat Kumar Chatterjee, Sarbani Chatterjee and Baisakhi Chatterjee (all through their constituted attorney, Kamala Naskar) sold, conveyed and transferred the Said Property to Dinabandhu Naskar, free from all encumbrances and for the consideration mentioned therein.
- 5.1.11 **Purchase by Vendor:** By a Deed of Conveyance dated 9th February, 2011, registered in the Office of District Sub Registrar IV, Alipore, in Book No. 1, CD Volume No. 4, at Pages 186 to 203, being Deed No. 899 for the year 2011, the Vendor purchased the entirety of the Said Property from Dinabandhu Naskar, free from all encumbrances and for the consideration mentioned therein.
- 5.1.12 **Absolute Ownership of Vendor:** In the aforesaid circumstances, the Vendor has become the undisputed and absolute owner of the Said Property, free from all encumbrances.
- 5.2 **Representations, Warranties and Covenants Regarding Encumbrances:** The Vendor represents, warrants and covenants regarding encumbrances as follows:
- 5.2.1 **No Acquisition/Requisition:** The Vendor has not received any notice from any authority for acquisition, requisition or vesting of the Said Property and declares that the Said Property is not affected by any scheme of the *Panchayat* Authority or Government or any Statutory Body.
- 5.2.2 **No Excess Land:** The Vendor does not hold any excess vacant land under the Urban Land (Ceiling and Regulation) Act, 1976 or any excess land under the West Bengal Land Reforms Act, 1965 or the West Bengal Estates Acquisition Act, 1953.
- 5.2.3 **No Encumbrance by Act of Vendor:** The Vendor has not at any time done or executed or knowingly suffered or been party or privy to any act, deed, matter or thing, including grant of right of easement, whereby the Said Property or any part thereof can or may be impeached, encumbered or affected in title.
- 5.2.4 **Right, Power and Authority to Sell:** The Vendor has good right, full power, absolute authority and indefeasible title to grant, sell, convey, transfer, assign and assure the Said Property to the Purchaser. In a meeting dated 20th April, 2012, the Board of Directors of the Vendor adopted a resolution to the effect that Tarun Bhattacharjee, Director, be authorized to sell *inter alia* the Said Property, on such terms

Tamal Bhattacharjee, has been authorized and empowered by the Vendor to sign this Conveyance upon observance of all due process of law and is thus competent and lawfully authorized to execute this Conveyance on behalf of the Vendor.

- 5.2.5 **No Dues:** No tax in respect of the Said Property is due to the local authority and/or any other authority or authorities and no Certificate Case is pending for realization of any dues from the Vendor.
- 5.2.6 **No Right of Pre-emption:** No person or persons whatsoever have/had/has any right of pre-emption over and in respect of the Said Property or any part thereof.



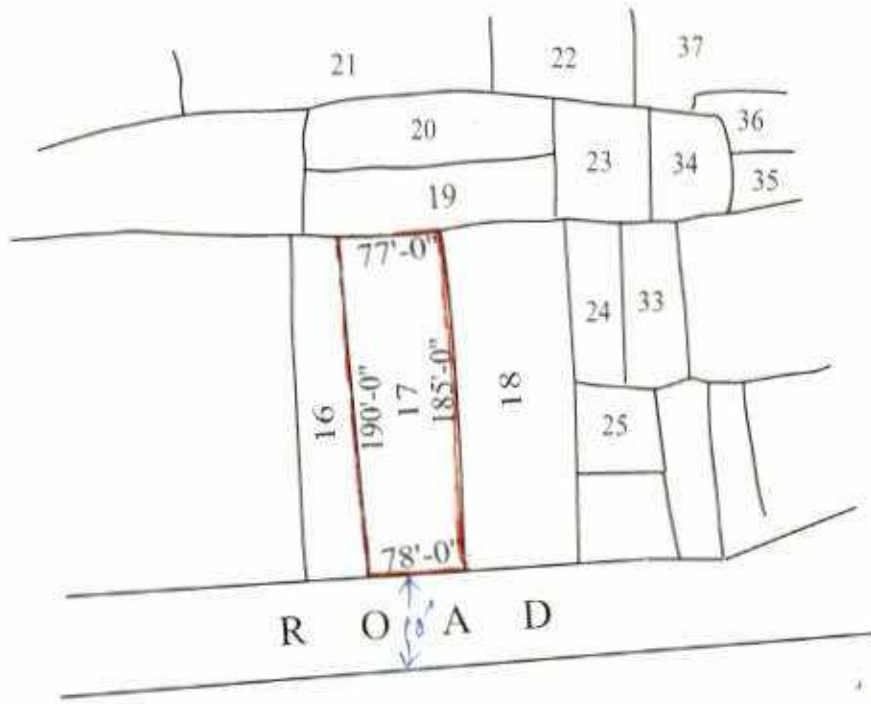
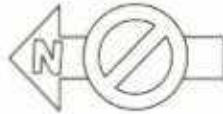
