- Demise of Kanai Das alias Kenai Das: Kanai Das alias Kenai Das, a Hindu, governed by the Dayabhaga School of Hindu Law, died intestate leaving behind him surviving his 4 (four) sons, namely, (1) Pasupati Das (2) Asutosh Das (3) Dasurathi Das and (4) Jaydeb Das and his only daughter, Sundari Naskar nee Das, as his only legal heirs and heiress, who jointly and in equal share inherited the right, title and interest of Late Kanai Das alias Kenai Das in the Mother Property, free from all encumbrances.
- Demise of Pasupati Das: Pasupati Das, a Hindu, governed by the Dayabhaga School of Hindu Law, died intestate leaving behind him (his wife, Sailabala Das since deceased), surviving his 5 (five) sons, namely, (1) Bijoy Das (since diseased) (2) Basanta Das alias Basanta Kr. Das (the Vendor herein) (3) Mohonto Das (4) Jayanta Das and (5) Srimanta Das and his 2 (two) daughters, namely, (1) Pratima Mondal nee Das and (2) Anima Das, as his only legal heirs and heiresses, who jointly and in equal share inherited the right, title and interest of Late Pasupati Das in the Mother Property, free from all encumbrances.
