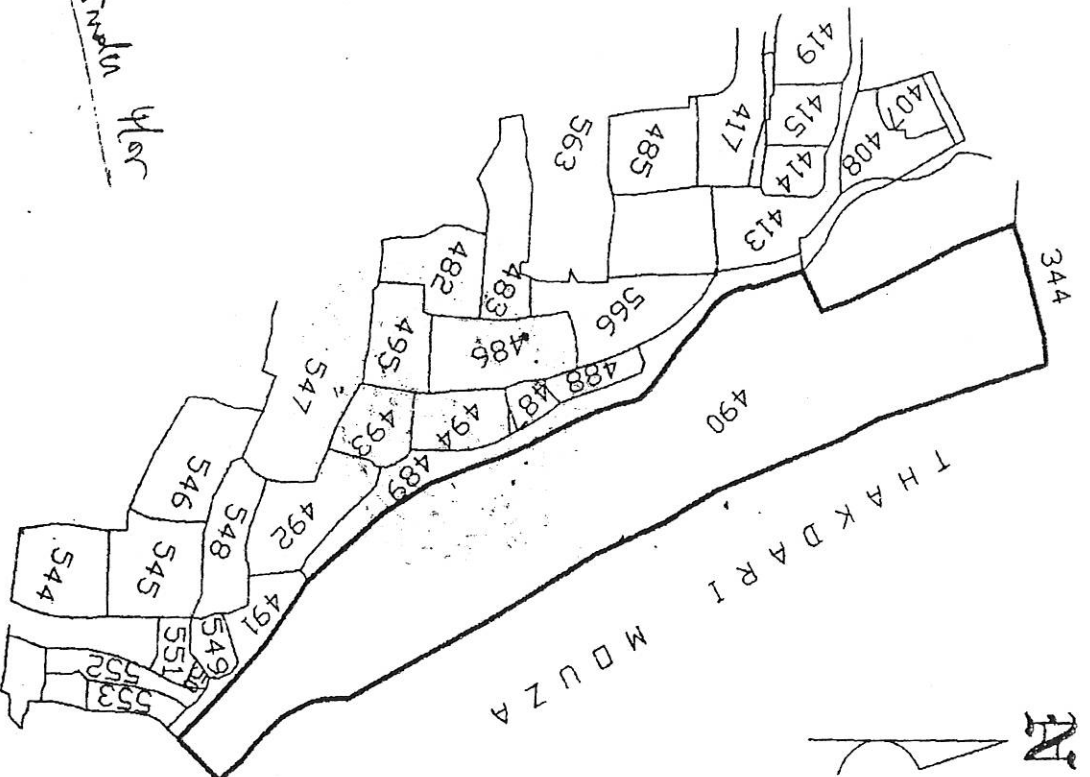

R.S. DAG NO.- 490, P.S.-RAJARHAT, DIST.-NORTH 24 PGS.

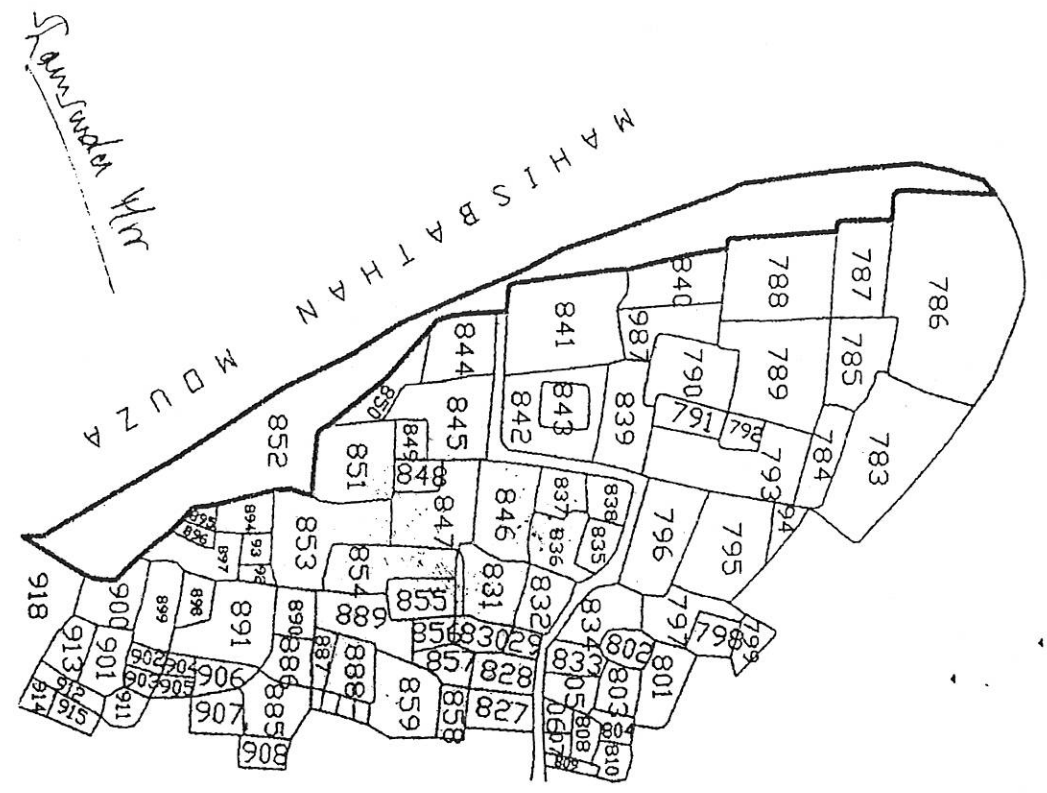
