**WHEREAS :**

L. The Vendor has represented to and assured the Purchaser as follows:

B. The land comprised in the said property is, inter alia, a part of land measuring about 22 Cottahs 11 Chittacks 31 Square feet equivalent to 37.57 decimals in R.S./ L.R. Dag No. 918 under L.R. Khatian No. 287 in Mouza Thakdari, P.S. Salt Lake Electronics Complex, J.L. No. 19, District North 24 Parganas purchased by the Vendor for valuable consideration by and under a Deed of Conveyance dated 17th August, 1994, registered at the office of the Additional District Sub-Registrar, Bidhan Nagar (Salt Lake City) in Book no. C. Although the said Deed of Conveyance dated 17th August, 1994 related to 37.57 decimals land, the Vendor herein obtained clear title and ownership only in respect of 24.12 decimals land which has been duly mutated in the name of the Vendor under L.R. Khatian no. 287 and the Vendor herein did not get any title or ownership or mutation in respect of 13.45 decimals of land. The said 13.45 decimals land actually belongs to and

has been mutated in favour of other entities and in view of this all the disputes and legal proceedings with such other entities have now been finally settled and under such settlement the Vendor has irrevocably accepted the title of the such other entities in whose favour mutation has been made in respect of the said 13.45 decimals land. The Vendor hereby declares that the Vendor does not have any right, title or interest whatsoever in the aforesaid 13.45 decimals land. Accordingly, by virtue of the aforesaid Deed dated 17<sup>th</sup> August, 1994, the Vendor herein has acquired title only in respect of 24.12 decimals land in Dag no. 918:

F. 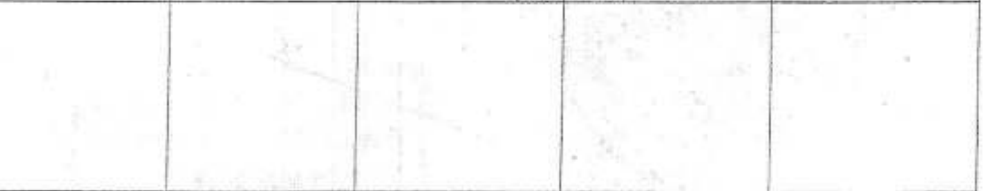
