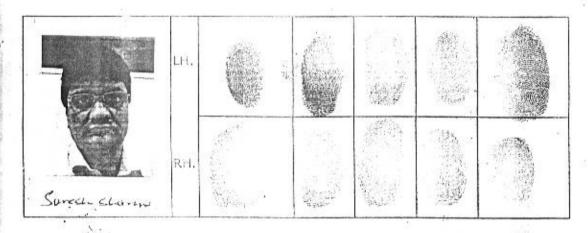

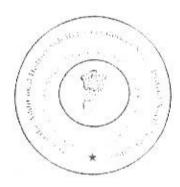
AREA OF LAND 7 84 Satak
