










AREA OF LAND : 2.23 Satak.



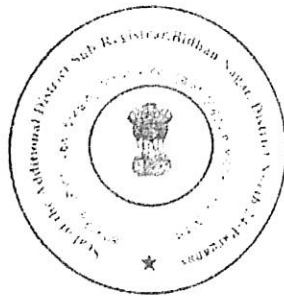


