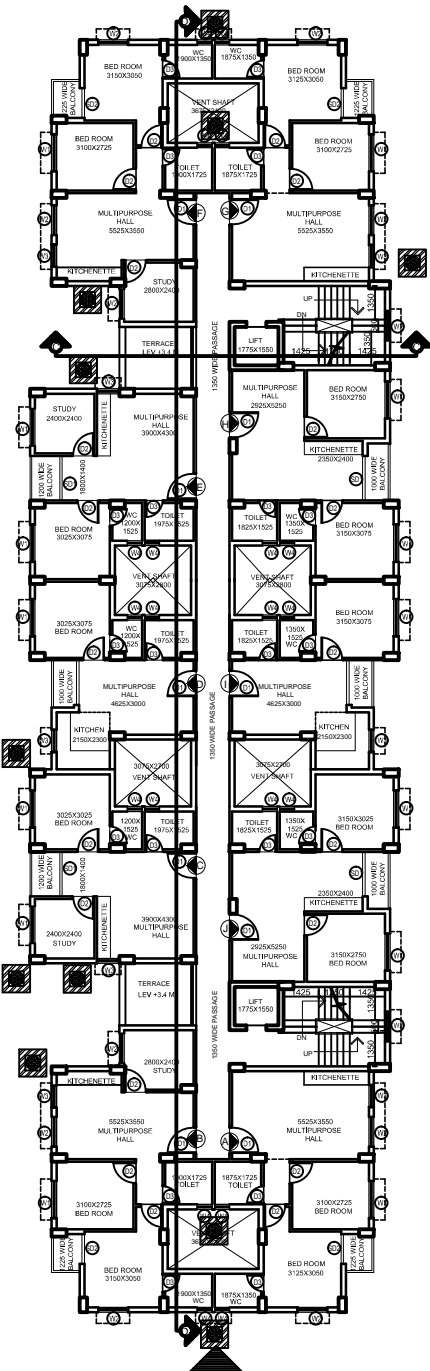

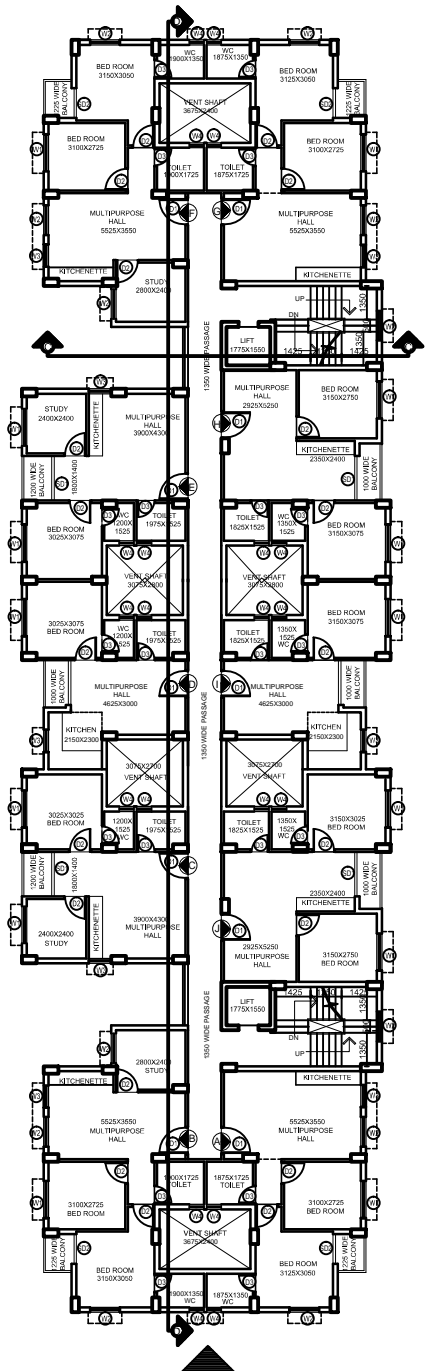

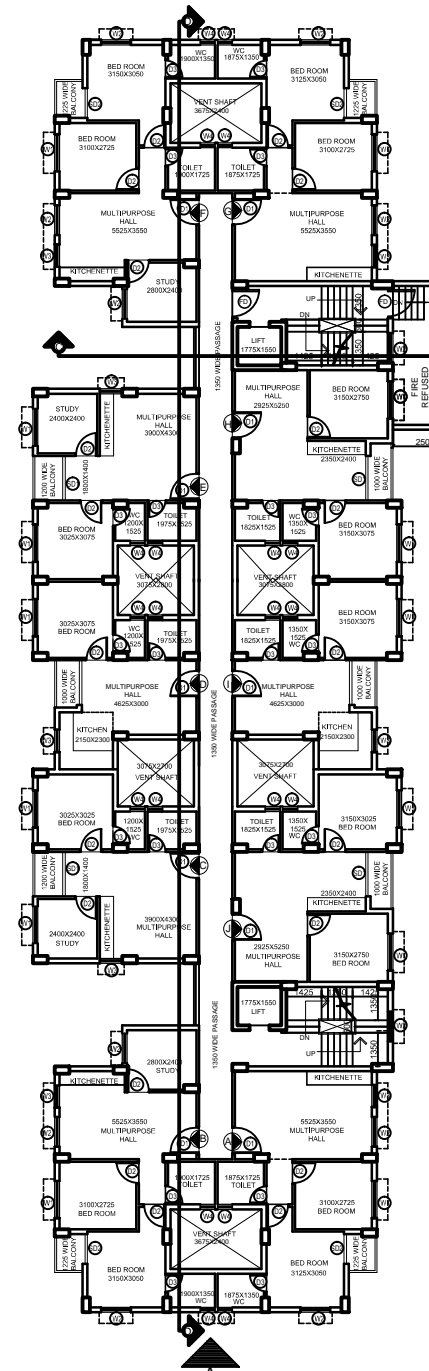
**GROUND FLOOR PLAN
 BLOCK 3**



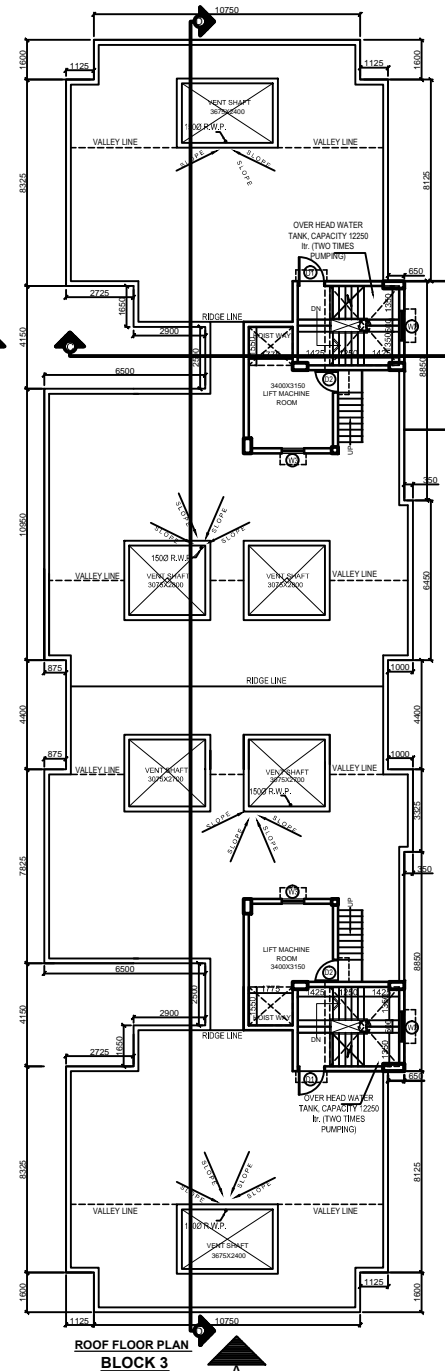
**FIRST FLOOR PLAN
