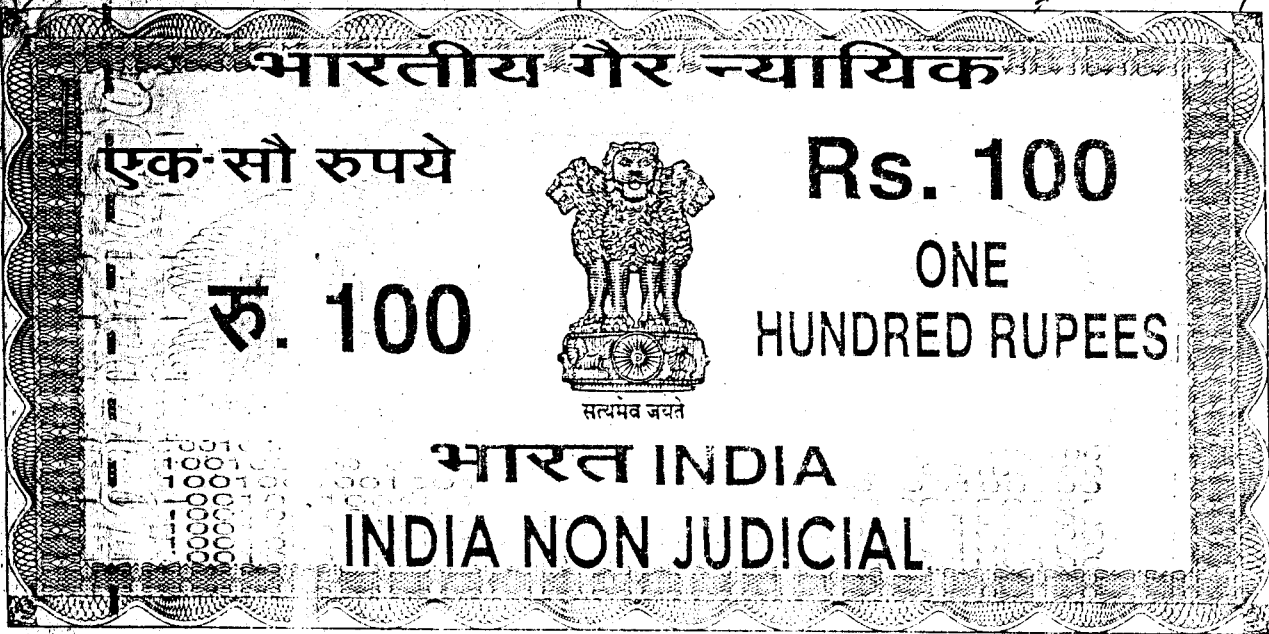

Baguiati, Kolkata - 700059, hereinafter referred to and called as the VENDORS (which term or expression shall unless excluded by or repugnant to the subject or context be deemed to include their heirs, executors, administrators, legal representatives and assigns) of the ONE PART.

AND

LTD., a registered company having it's principal place of business at 52, Weston Street, 4<sup>th</sup> Floor, Kolkata-700012, represented by it's authorised signatory SRI RABI SINGHA ROY, son of Late Ganesh Singha Roy, by Nationality-Indian, by faith-Hindu, by Occupation - Business residing at 52, Weston Street, 4<sup>th</sup> Floor, Kolkata-700012, hereinafter called and referred to as the PURCHASER (which terms or expressions shall

unless excluded by or repugnant to the subject or context be deemed to include its executors, administrators, legal representatives and assigns) of the OTHER PART.
