With reference to above cited letter, "No Objection" is hereby given for proposed residential complex on the land mentioned on the subject above which has a road distance around 12.66 Km (approximately) from the boundary of the Mahananda Wildlife Sanctuary at Darjeeling District (as reported by the DFO, Darjeeling Wildlife Division) with the following conditions:

1. Necessary precautions should be taken to prevent any activity detrimental to birds/animals and their free

movement in the area, if any.

2. They should not use unnecessary bright lights that could deter the biological rhythm of the birds any other wildlife, in the area.

3. There should not be open garbage dumps around which may attract birds and other wild animals.

4. All directive as specified as specified by the MoEF & CC (ESZ Division), Govt. of India published in the Gazette of India, vide No. 3344(E), dtd. 16.10.2017 regarding declaration of Eco-sensitive Zone, around Mahananda Wildlife Sanctuary at Darjeeling, in the State of West Bengal should be followed scrupulously (copy enclosed).

Any mandatory condition/ permission from other authorities like Army/Air Force/Para-Military etc. shall be

the responsibility of the company constructing the housing complex.

6. There should not be any violation of Wildlife Protection Act, 1927 and any other rules in vogue.
