- 1. That Promoter, Elita Garden Vista Project Private Limited has a legal title to the land on which the development of the proposed project is to be carried out.
- 2. That the said land is free from all encumbrances except as detailed in the 4th row attachment.
- 3. That the time period within which the project shall be completed by the Promoter is $31^{\rm st}$ December 2020.
- 4. That seventy percent of the amounts realised by the Promoter for the real enstate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
