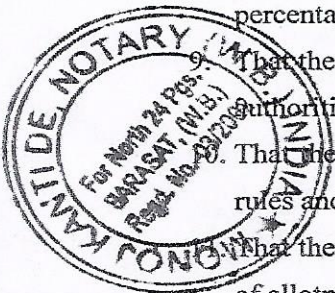

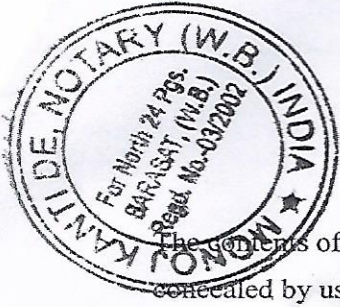
2. That the firm has a legal title on the land on which the declaration of the ongoing project is carried out by virtue of a Development agreement dated 15th July, 2020.
