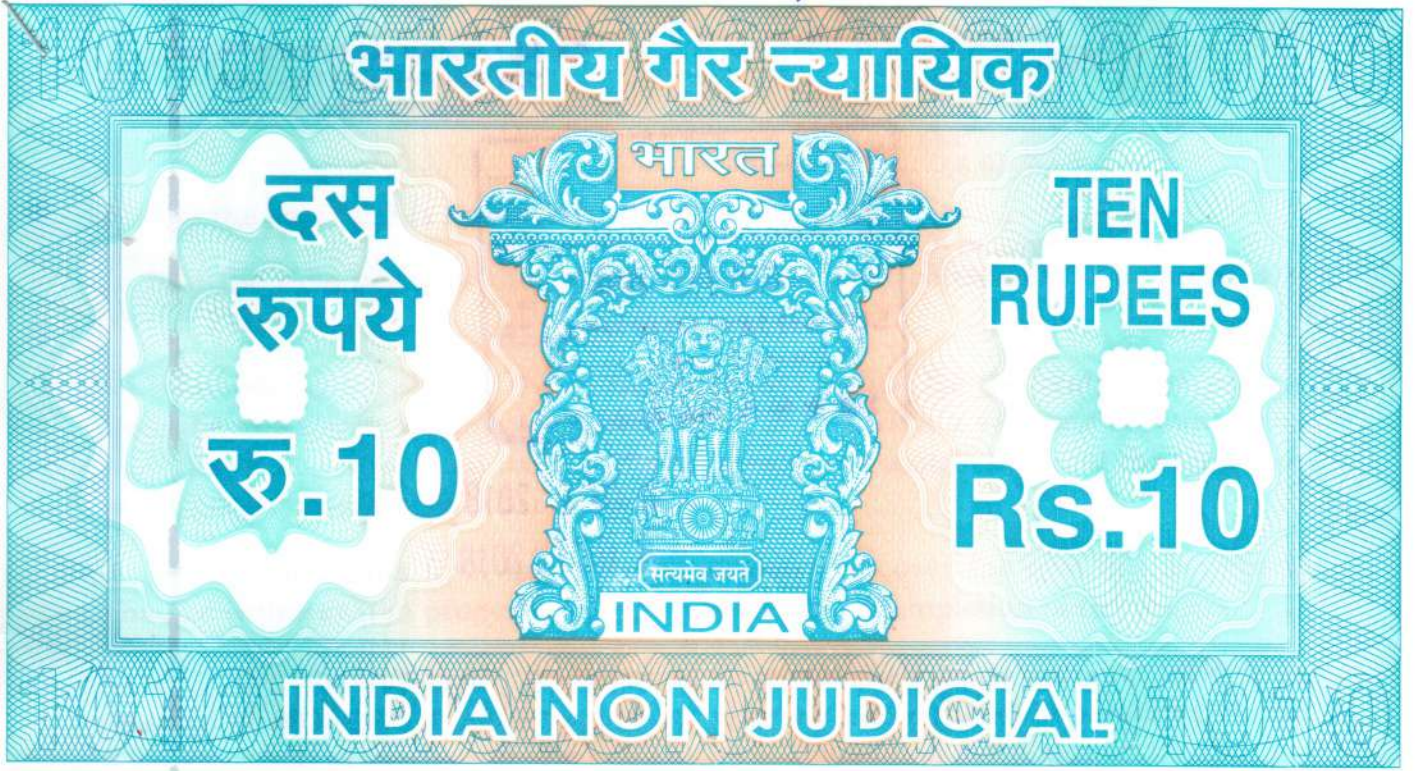

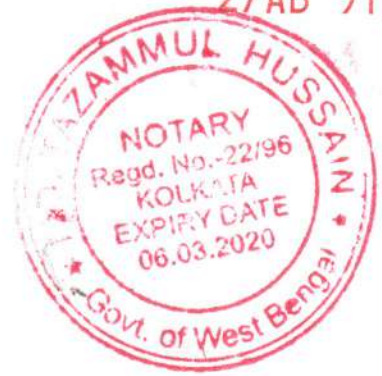
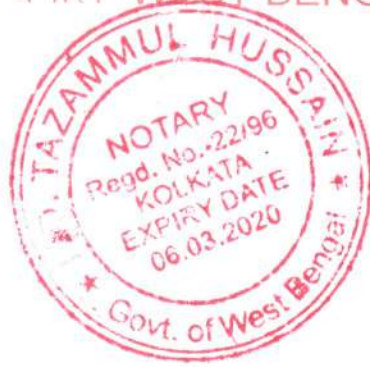

- 10. That I shall not discriminate against any allottee at the time of allotment of any apartment , plot or building , as the case may be, on any grounds.

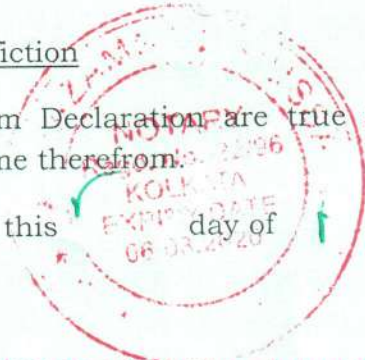
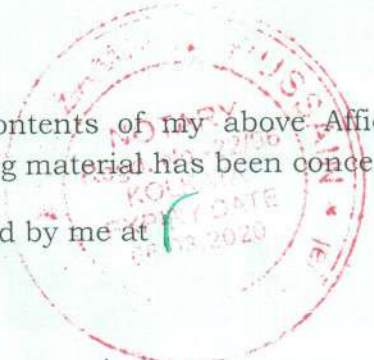
