Khatian No. 133, R.S. Khatian No. 189, C.S. Dag No. 448, R.S. Dag No. 455, Touzi No. 2998, J.L. No. 12, Re. Sa 212, Mouza Madurdaha, District 24 Parganas (South).

By a Deed of Gift and made between Nagendra Nath Shastri therein referred to as the Donor of the One Part and Amiya Bala Dasi therein referred to as the Donee of the Other Part, the Donor therein duly gifted to the Donee therein All That the piece and parcel of land measuring about 4 Cottahs out of 9 Bighas 7 Cottahs, all situated at C.S. Khatian No. 133, R.S. Khatian No. 189, C. S. DagNo. 448, R. S. Dag No. 455, Touzi No. 2998, J.L. No. 12, Re. Bulu Banerjee, therein jointly referred to as the Vendor of One Part and Sri Shib Chandra Pal, son of late Kenaram Pal therein referred to as the Purchaser of the other Part and registered at the Office of District Registrar, Alipore, in Book No. I, Volume No. 326, Page 111 to 117, Being No. 10144 for the year 1981, the vendor therein for the consideration and on the terms and conditions mentioned therein duly sold, transferred and conveyed to the Purchasers therein ALL THAT the piece and parcel of land measuring about 4 Cottahs 8 Chittacks 36 Sq.Ft. all situated at Plot No. 27. Khatian 133, R.S. Khatian No. 189, C.S. Dag No. 448, R.S. Dag No. 455 under Mouza Madurdaha, J.L. No. 12, R.S. By a Registered Deed of Sale dated 16.08.1996 made by and between Sri Samar Banerjee son of Late Pran Krishna Banerjee, represented by his Constituted Attorney Sri Asharfi Poddar son of Late Ganesh Poddar therein referred to as the Vendor of One Part and Sri Sanjay Singh son of Late Ram Dayal Singh therein referred to as the Purchaser of the other Part and registered at the Office of Additional District Sub-Registrar, Sealdah, District 24 Parganas in Book No. I, Volume No. 46, Pages 276 to 292 Being No. 2079 for the year 1996, the Vendor therein for the consideration and on the terms and conditions mentioned therein duly sold, transferred and conveyed to the Purchaser therein ALL THAT the piece and parcel of land measuring about 2 Cottahs 4 Chittacks 11 Sq.Ft. all situated at Plot No. 27A, C.S. Khatian 133, R.S. Khatian No. 189, C.S. Dag No. 448, R.S. Dag No. 455 under Mouza Madurdaha, J.L. No. 12, R.S. - S. The Vendor agreed to sell and the purchasers agreed to purchase ALL THAT piece and parcel of land measuring about 2 Cottahs 4 Chittacks 11 Sq.ft. be the same a little more or less together with the structure thereon morefully and particularly described in the First Schedule hereunder written and hereinafter referred to as the said premises.
- T. At or before the execution of these presents, the Vendor and Confirming Party jointly and severally has represented, assured and undertaken to the purchasers and given warranties and indemnities as follows:-
- (i) That the Vendor herein is absolute lawful owner of the said premises and appurtenant thereto, free from all encumbrances, charges, liens, lispens, attachments, trusts, claims, demands, mortgages, wakfs, debutters, debts, uses, executions, liabilities, prohibitions, restrictions, leases, tenancies, licenses,

It is expressly clarified, understood and confirmed that it is only on the basis of the aforesaid assurances, representations, undertakings, warranties and indemnities of the Vendor that the Purchasers herein agreed to purchase and acquire the said premises and would not have otherwise agreed to purchase the said premises nor would has agreed to pay the amount as hereinafter

appearing, in the absence of any of such representations, undertakings, warranties, assurances and indemnities by the Vendor herein.

W. The Vendor has agreed to sell and the purchasers have agreed to purchase the said premises having an area of 2 Cottahs 4 Chittacks 11 Sq.ft., morefully described in the First Schedule hereunder written free from all charges, mortgages liens, lispensens, litigations at and for the consideration of **Rs.15,00,000 /-** (Rupees *fifteen* Lacs) only and on the terms and conditions as will appear hereinafter.

**NOW THIS INDENTURE WITNESSETH** that in pursuance of the said Agreement and relying on the representation of the Vendor and believing the same as true and correct and in consideration of the sum of **Rs.15,00,000/-** (Rupees *fifteen* lacs) only paid by the purchasers to the Vendor on or before the execution of these present (the receipt whereof the Vendor doth hereby admit and acknowledge and discharge and release the said land and every part thereof unto the purchasers) the vendor doth hereby sell, grant, convey, transferred by way of sale, assign and assure unto the purchasers and hereby release relinquish and transfer all his


