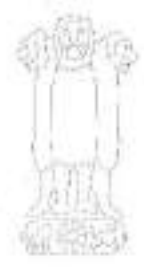

T. PAN:-ACBPA8391B).

Road, Siliguri, P.O.-Siliguri Bazar, Pin Code-734005, P.S.-Siliguri, District-Darjeeling, in the State of West Bengal, the person named herein shall hereinafter be referred to and called as "**THE DONEE**" or "**THE SECOND PARTY**" (Which name and expression shall, unless otherwise expressed or is excluded by or repugnant to the subject or context, be deemed to mean and include his legal heirs, executors, successors, administrators, legal representatives and assigns) of the **SECOND PART**. (I. T. PAN:-AJFPA4973N).

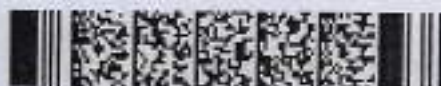




