

- 2. That the said land has been equity mortgage by Allahabad Bank thought a loan agreement of construction finance for the proposed project.
- That the time period within which the project shall be completed by me/promoter is 31st 3. April, 2021.
- That seventy percent of the amounts realized by me/promoter for the real estate project 4. form the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
- 6. That the amounts form the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project that I/promoter shall get the accounts audited within six month after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- That I/Promoter shall take all the pending approvals on time, form the competent 7. authorities.
- 8. That I/Promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

That I/ Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot of building, as the case may be, on any grounds.
