16. MORTGAGE OR CREATION OF CHARGE

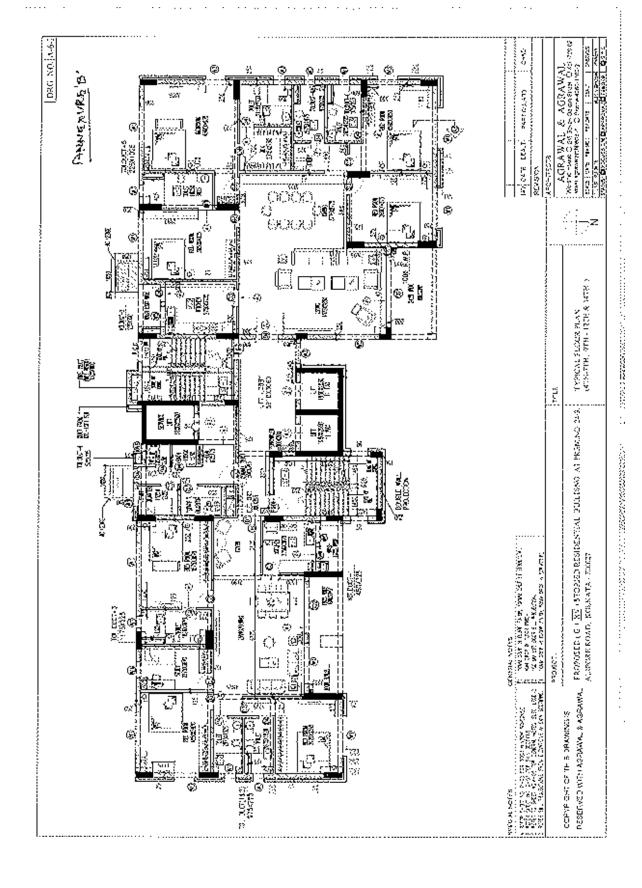
