Construction of garbage vat, soak pit & waste water should be done by the owner.

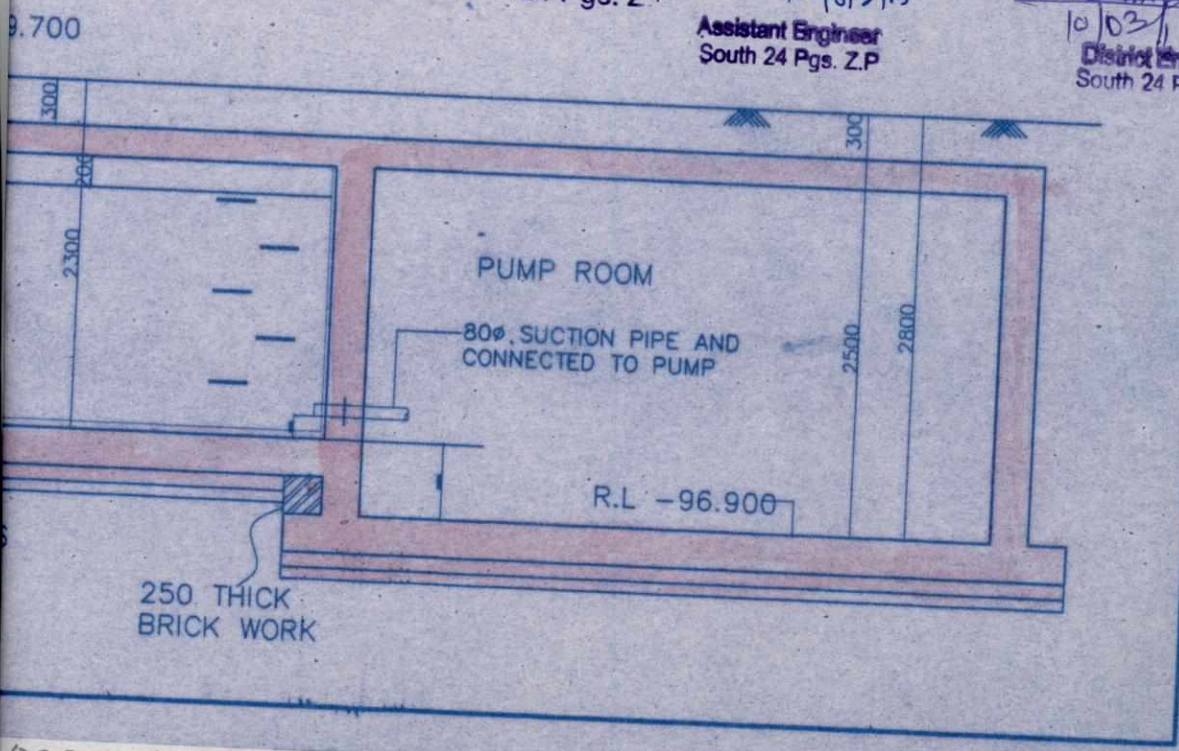
