AFFIDAVIT CUM DECLARATION

Affidavit cum Declaration of MR. PRAKASH JOSHI, duly authorized by the promoter of the proposed project SALARPURIA SIGNUM COMPLEX LLP, a limited liability partnership incorporated under the Limited Liability Partnership Act, 2008, having its office at 7, Chittaranjan Avenue, 1st floor, P.S. Bowbazar, Kolkata - 700 072, having PAN ACFFS8401G, vide its authorization dated 30.08.2018;

I, PRAKASH JOSHI, authorized signatory of the promoter SALARPURIA SIGNUM COMPLEX LLP, duly authorized by the promoter of the proposed project (VICTORIA VISTAS), do hereby solemnly declare, undertake and state as under:

1. That DAMODAR ROPEWAYS & INFRA LTD. (formerly known as Indian Ropeways & Engineering Company Limited) having its registered office at No.1/A Vansitart Row, P.S. Hare Street, Kolkata 700 001 and eight other companies, all represented through their authorized signatory Mr. Champa Lal Chamarla son of Late Thakursi Das Chamarla of No. 1/A Vansitart Row, P.S. Hare Street, Kolkata 700 001 has a legal title to the land on which the development of the proposed project is to be carried out

AND

a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

2. That the said land is free from all encumbrances.

3. That the time period within which the project shall be completed by the promoter is December, 2021.

4. That seventy per cent of the amounts realised by the promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.

6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project that I/promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

7. That the promoter shall take all the pending approvals on time, from the competent authorities.

8. That the promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

9. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
