This indenture made the 17th day of February one thousand nine hundred and twenty one Between The Corporation of Calcutta, a Body Corporate constituted under and by virtue of Act 30/1899 (Bengal Code) (hereinafter called "the Corporation" which expression shall unless excluded by or repugnant to the context be deemed to include its successors and assigns) of the one part and Sir Charles Henry Kesteven of 26 Dalhousie Square in the town of Calcutta and The Honourable Mr Justice Babington Bennett Newbould of Harrington Mansions Calcutta aforesaid two of the members and stewards of the Royal Calcutta Turf Club (hereinafter for the sake of brevity referred to as "the Purchasers" which expression shall unless excluded by or repugnant to the context be deemed to include the survivor of them and the heirs executors administrators and/or assigns of such survivors) of the other part.

WHEREAS the Corporation is the absolute owner and proprietor of the land hereditaments and premises hereinafter described and intended to be hereby conveyed free from incumbrances and has agreed to sell the same to the Purchasers as Trustees for the said Club for the price or sum of Rupees Eight thousand six hundred and ninety one annas ten and fries eight.

Now this Indenture Witnesseth that in pursuance of the said agreement and in consideration of the sum of Rupees Eight thousand six hundred and ninety one annas ten and fries eight on or before the execution of these presents to the Corporation paid by the Purchasers out of the funds of the said Club (the receipt whereof the Corporation doth hereby acknowledge and from the same doth hereby release the Purchasers) the Corporation doth hereby grant convey and transfer unto the Purchasers [All That and those the revenue free land hereditaments and premises containing an area of four cottahs five chittacks and twenty four square feet or thereabouts situate within the Municipal limits of the Town of Calcutta and adjoining the premises No.11 Goaltuli Road now premises No.6/1/1 Bhowanipur Road in the Registration District Twenty Four Pergunnahs Sub Registry Alipore Thanna Bhowanipore Dihie Panchannagram

Ground Division VI Sub Division A Village Bhowanipur forming a portion of the Holding No.1 (The recorded area of the entire Holding being Three Bigha nine cottahs twelve chittacks and thirty square feet and are butted and bounded in the manner following that is to say on the North by Corporation land on the East by No.11 Goaltuli Road on the South and on the West by Corporation land) which said premises are delineated in the plan annexed hereto and thereon coloured green Or howsoever otherwise the said land hereditaments and premises or any part thereof now are or is or at anytime heretofore were or was situated butted bounded called known described or distinguished together with all erections yards compounds trees fences hedges ditches wells sewer drain water courses liberties privileges easements rights lights appendages and appurlenances whatsoever to the said land hereditaments and premises or any part thereof belonging or in anywise appertaining or morally held or occupied therewith or reputed to belong or be appurtenant thereto and all the estate right Title interest property claims and demand whatsoever of the Corporation of in to or upon the said land hereditaments and premises and every part thereof and all deeds evidences writings and other documents whatsoever exclusively relating thereto in the possession of the Corporation or which the Corporation can procure without suit.

To have and to hold the said land hereditaments and premises hereinbefore expressed to be hereby granted with the appurtenances unto the Purchasers for ever as joint Tenants And the Corporation doth hereby covenant with the Purchasers that notwithstanding any act deed or thing by the Vendor done or executed or knowingly suffered to the contrary the Corporation now has good right to grant convey and transfer the said land hereditaments and premises hereby granted conveyed and transferred or expressed so to be unto the Purchasers in manner aforesaid And that the Purchasers shall and may at all times hereafter peaceably and quietly possess and enjoy the said land hereditaments and premises and receive the rents and profits thereof without any lawful eviction interruption claim or demand whatever from or by the Corporation



whatsoever And further that the Corporation and all other persons having or lawfully or equitably claiming any estate or interest in the said land hereditaments and premises or any part thereof shall and will from time to time and at all times hereafter at the request and cost of the Purchasers do and execute or cause to be done and executed all such acts deeds and things and assurances in the law whatsoever for further or more perfectly assuring the said land hereditaments and premises and every part thereof unto the Purchasers in manner aforesaid as shall and may be reasonably required In Witness whereof.
