

With reference to your application for seeking permission for Proposed Construction of "LALIT SMRITI RAJLAXMI ABASAN O MARKET COMPLEX" (B+G+4 STORIED RESIDENTIAL & COMMERCIAL BUILDING) building plan over Mouza Chotokhelna (J.L. No. 195) , PLOT NO.-198, khatian no.-1668,1669,1670 under jurisdiction of Maligram G.P. within Pingla Panchayat Samity in the District of Paschim Medinipur, permission is hereby granted subject to the following condition:

1. Permission for construction of the structure / building is valid up to 3(three) year.
2. Permission for construction of the structure/ building is valid for occupancy of use of Residential purpose as well as commercial purpose.
3. The structure or building for which permission is granted shall have to be completed within 3(three) year.
4. The construction will be undertaken as per sanctioned plan only and no deviation from the vetted plan and from the provisions of GO No 232/AD/PN/O/I/1A-07/2016 dated 29.03.2018 will be permitted.
5. For approach road, permission from the concerned road authority has to be obtained.
6. Precautions (sheet piling) should be taken from your end during execution so that any construction by you should not affect existing neighboring building foundations already constructed in the adjacent plots any way due to this construction.
7. Rules of other Govt order either issued by State Govt or Central Govt from time to time in this respect and which are in vogue should be abide by the landowner.
8. Two set of the site plan and the sanctioned building plan submitted along with the application is returned.
