AND WHEREAS, while in joint possession of the aforesaid landed property the said Dulal Mondal sold, conveyed and transferred ALL THAT Shali land measuring 4.08 decimals to Jafar Ali Mondal son of Kabil Mondal vide Book No. 1, Deed No. 5318 registered in the office of the Additional District Sub-Registrar, Bidhannagar (Salt Lake City) in the District of North 24 – Parganas and the said land has been mutated in favour of Jafar Ali Mondal vide L.R. 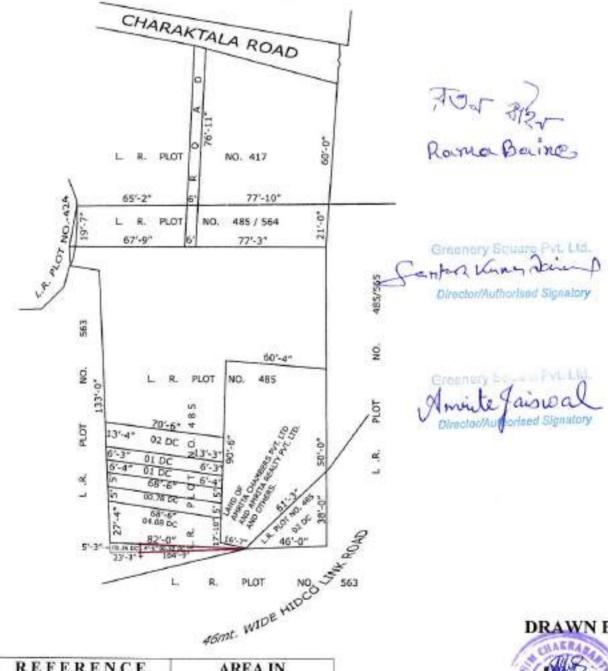

PLOT REFERENCE AREA IN COL. DECIMALS L.R. PLOT NO. 485 (P) 00.52

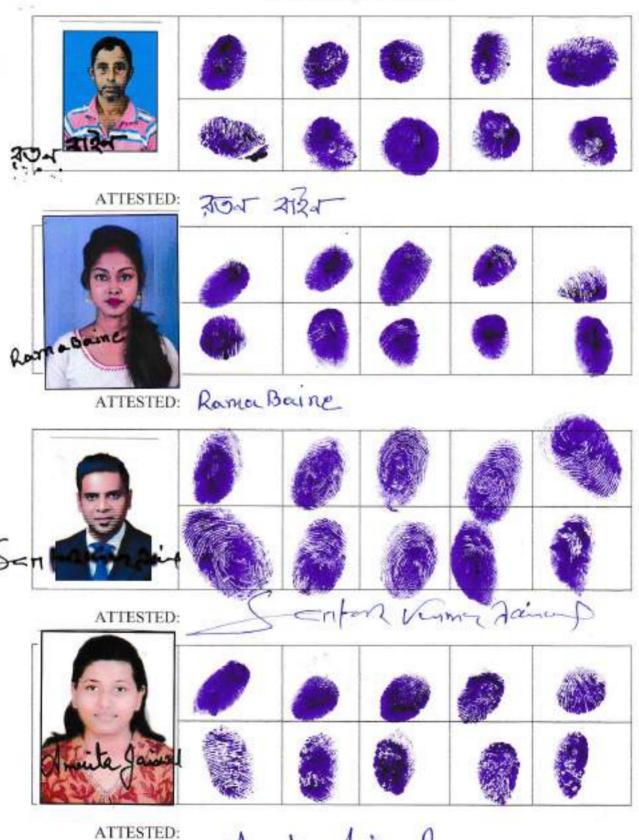
