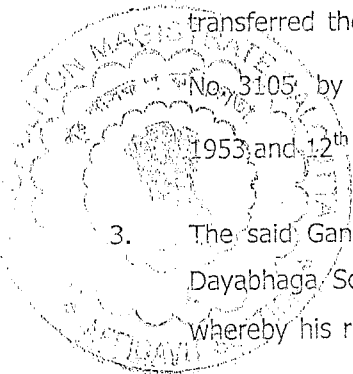

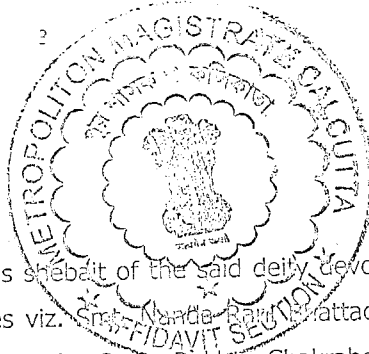

I, Suman Chakrabarti, son of Jyotirindra Nath Chakrabarti, aged about 49 years, by faith Hindu, by occupation---Landlord and at present residing at 20/1/2, Dr. Bidhan Chandra Roy Road, Dakshin Jagatdal, P.O.Jagadal, P.S. Sonarpur, Kolkata-700 151, do hereby solemnly declare and say as follows:-

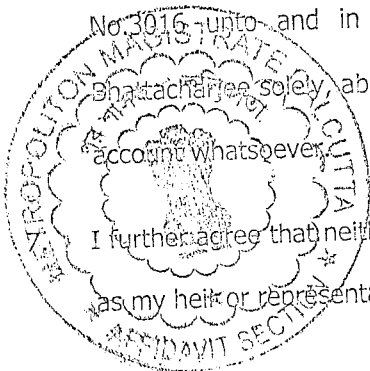
1. At all material times one Abinash Chakraborty was seized and possessed of or otherwise well and sufficiently entitled to All That piece and parcel of 'Bastu' land containing by estimation an area of 77 Sataks more or less out of 1.49 Satak more or less comprised in part of R. S. Dag No. 3106 corresponding to L.R.Dag No. 3143 appertaining to Khatian No. 411 and also as sole shebait of the deity Sri Sri Raj Ballav Shib Thakur was holding All That 'Doba' land measuring 14 Satak comprised in R.S. Dag No. No. 3105 corresponding to L.R.Dag No. 3142 appertaining to Khatian No. 1315/1.
2. On the intestate demise of the said Abinash Chakraborty the shebaitship of the said deity and the land held by the said deity in R.S.Dag No. 3105 devolved unto Ganesh Chandra Bhattacharjee as one of his legal heirs being son of his daughter viz. Radha Rani. The other heirs viz. Sunil Kumar Bhattacharjee, son of Radga Rani and Amar Chakraborty , son of the other daughter viz. Provati Chakraborty denounced such shebaitship and transferred their right and interest in the said land comprised in R.S.Dag No. 3105 by two several registered Deeds of Conveyance dated 14<sup>th</sup> July, 1953 and 12<sup>th</sup> October, 1955 respectively.
3. The said Ganesh Chandra Bhattacharjee who was a hindu governed by Dayabhaga School of Hindu Law died intestate on 22<sup>nd</sup> February, 2004 whereby his right and interest in the abovementioned piece and parcel of



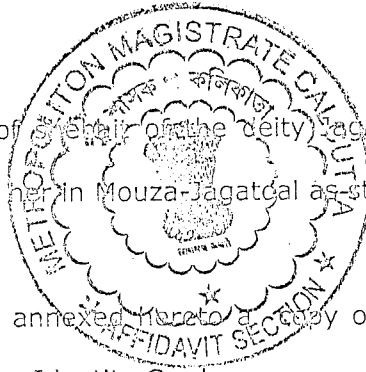


land including the land held as shebait of the said deity devolved unto his legal heirs and representatives viz. Smt. Nanda Bai Bhattacharjee (wife), Asok Kumar Bhattacharjee (son), Smt. Rekha Chakraborty (married daughter), Smt. Rita Bhattacharjee (daughter), Smt. Nipa Bhattacharjee (daughter) and the deponent herein along with his brothers viz. Manas Chakraborty and Ashish Chakraborty being the sons of the legal heirs of his pre-deceased daughter viz. Smt. Reba Chakraborty.

4. On an application made by the said Ganesh Chandra Bhattacharjee before the Learned District Judge at Alipore being Misc. Case No. 267 of 1988, the Learned Judge by his order dated 16<sup>th</sup> September, 1988 permitted the said Ganesh Chandra Bhattacharjee, to act as sole shebait of the said deity with power to deal with the land comprised in R. S. Dag No. 3105 in discharging his function and duties as such Shebait.
  5. I say that on the intestate demise of the said Ganesh Chandra Bhattacharjee I along with my other legal heirs inherited an undivided share in the assets and properties left behind by him in his individual capacity in the land comprised in R.S. Dag No. 3106 and also as the Shebait of the said deity in the land comprised in Dag No. 3105 is concerned.
  6. Out of my own free will and without being influenced in any manner whatsoever I have now agreed to release and relinquish my right or claim in the Estate left behind by the said Ganesh Chandra Bhattacharjee (as Shebait) in respect of R. S. Dag No. 3105 and also in respect of R. S. Dag No. 3016 upto and in favour of my maternal uncle viz. Asok Kumar Bhattacharjee solely, absolutely and without any reservation or claim on any account whatsoever.
- I further agree that neither me nor any person claiming through or under me as my heir or representative shall be entitled to claim any right or interest



to my share in the office of (rental of the deity) Jagatdal and/or the property held by her in Mouza-Jagatdal as stated hereinabove.



9. In support of my identity I annexed hereto a copy of my Aadhaar Card/Pan Card/Voter Identity Card.

10. I say that the statements made hereinabove are true to the best of my knowledge.

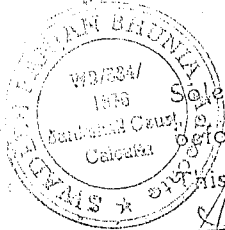
