

- That the time period within which the project shall be completed by (me/the. promoter) is 36 MONTHS FROM THE DATE OF SANCTION BUILDING PLAN.
- That seventy percent of the amounts realized by (me/the promoter) for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by (me/the promoter) in proportion to the percentage of completion of the project.
- That the amounts from the separate account shall be withdrawn by (me/the promoter) after it is certified by an enginer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- That (I/the promoter) shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verfied during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- That (I / the promoter) shall take all the pending approvals on time, from the competent authorities.
- That (I/ the promoter) (have/has) furnished such other documents as have been prescribed by the Act and the rules and regulations made there under.
- That (I / the promoter) shall not discriminate against any allottce at the time of allotment of any apartment, plot or building, as the case maybe.
