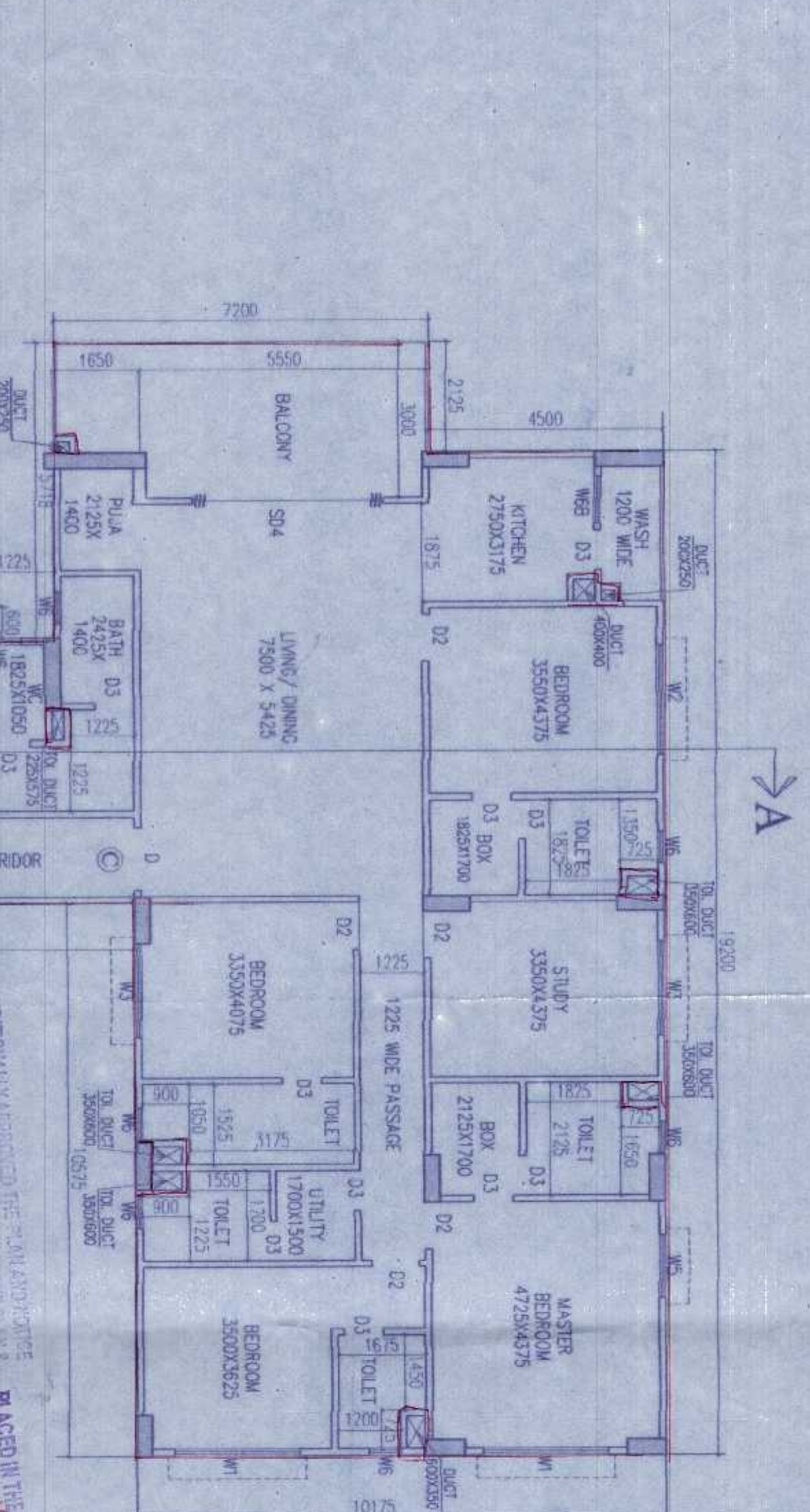
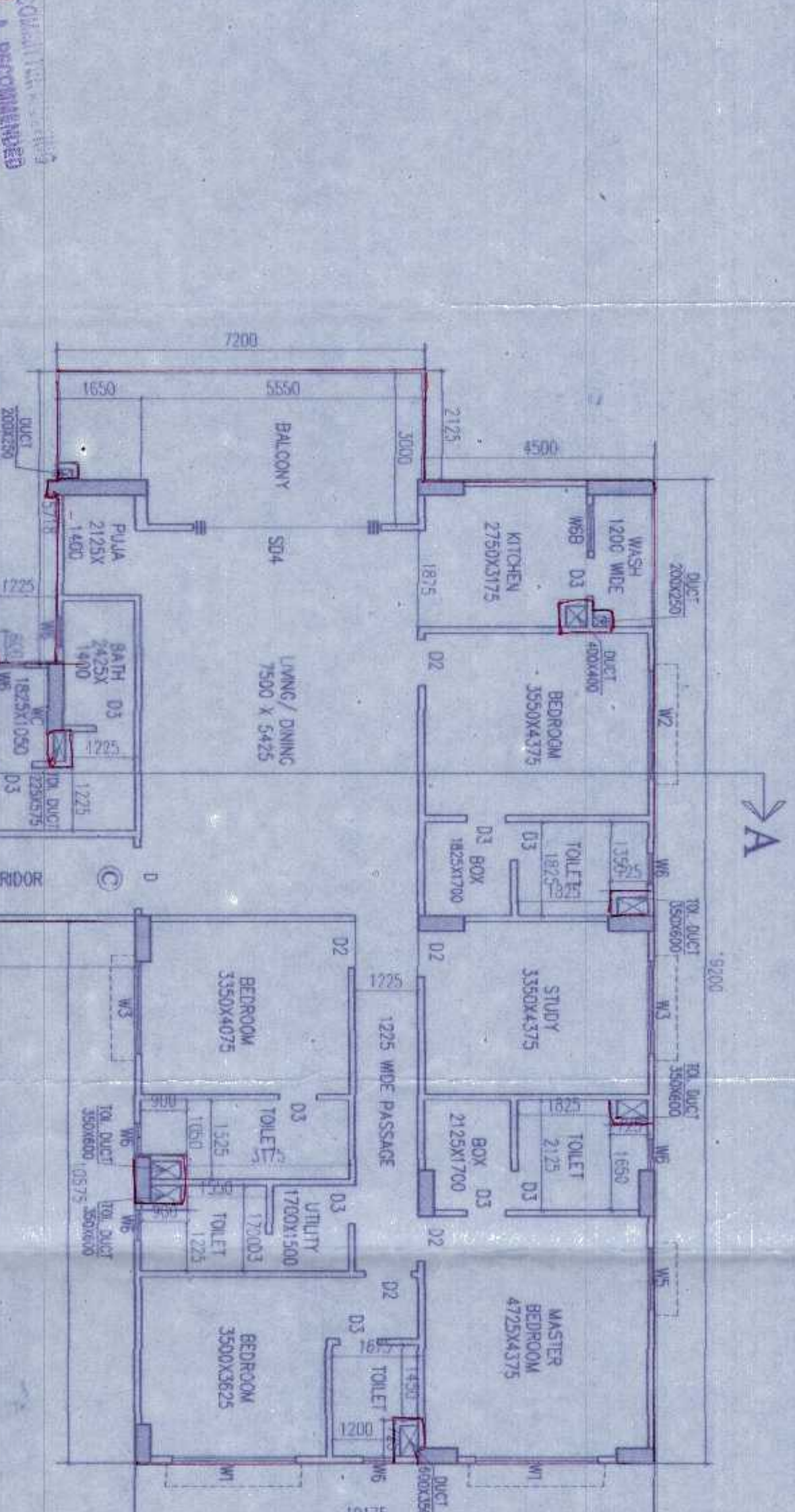


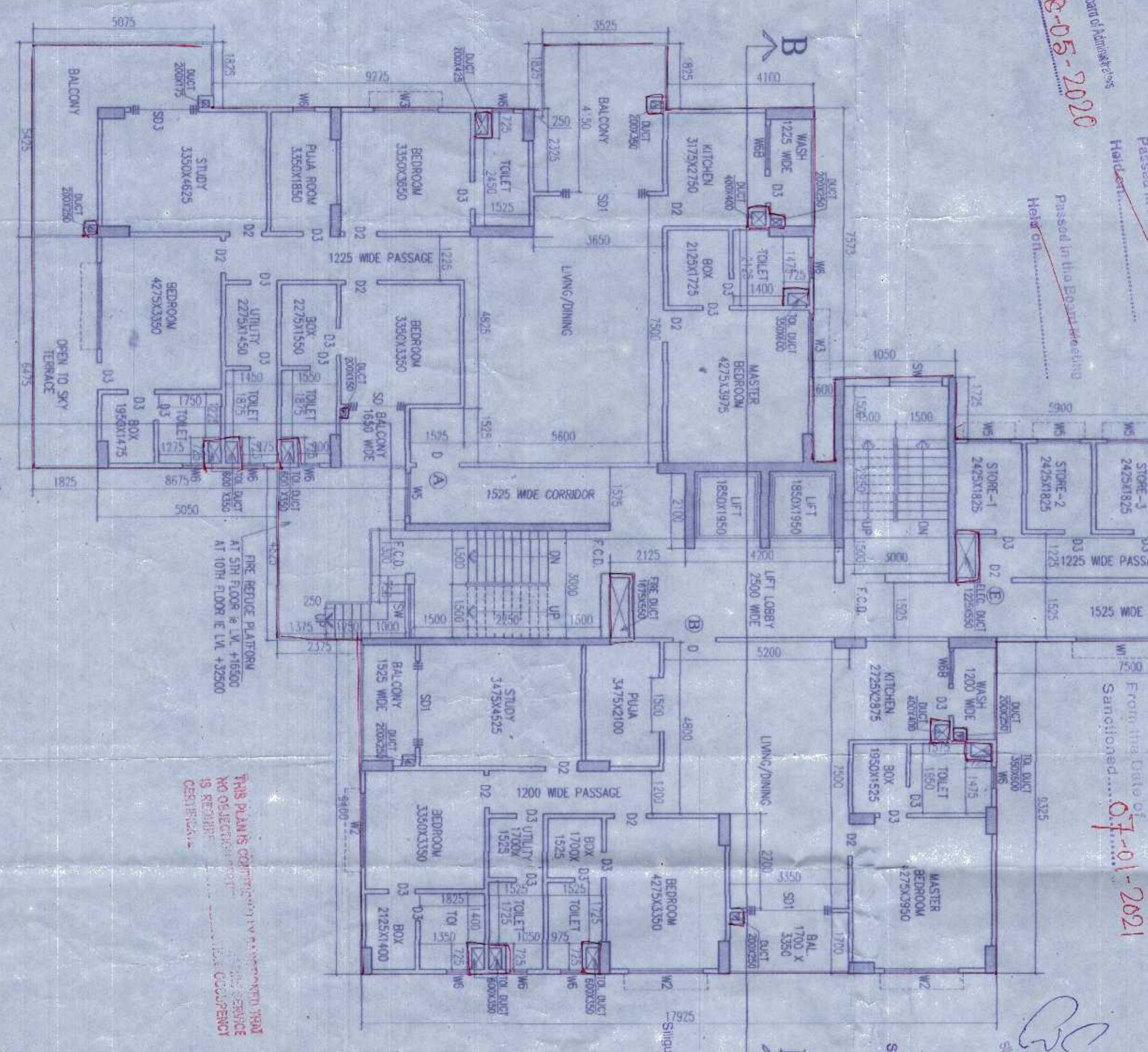
PROPOSED G + 11 STD. RESIDENTIAL BUILDING



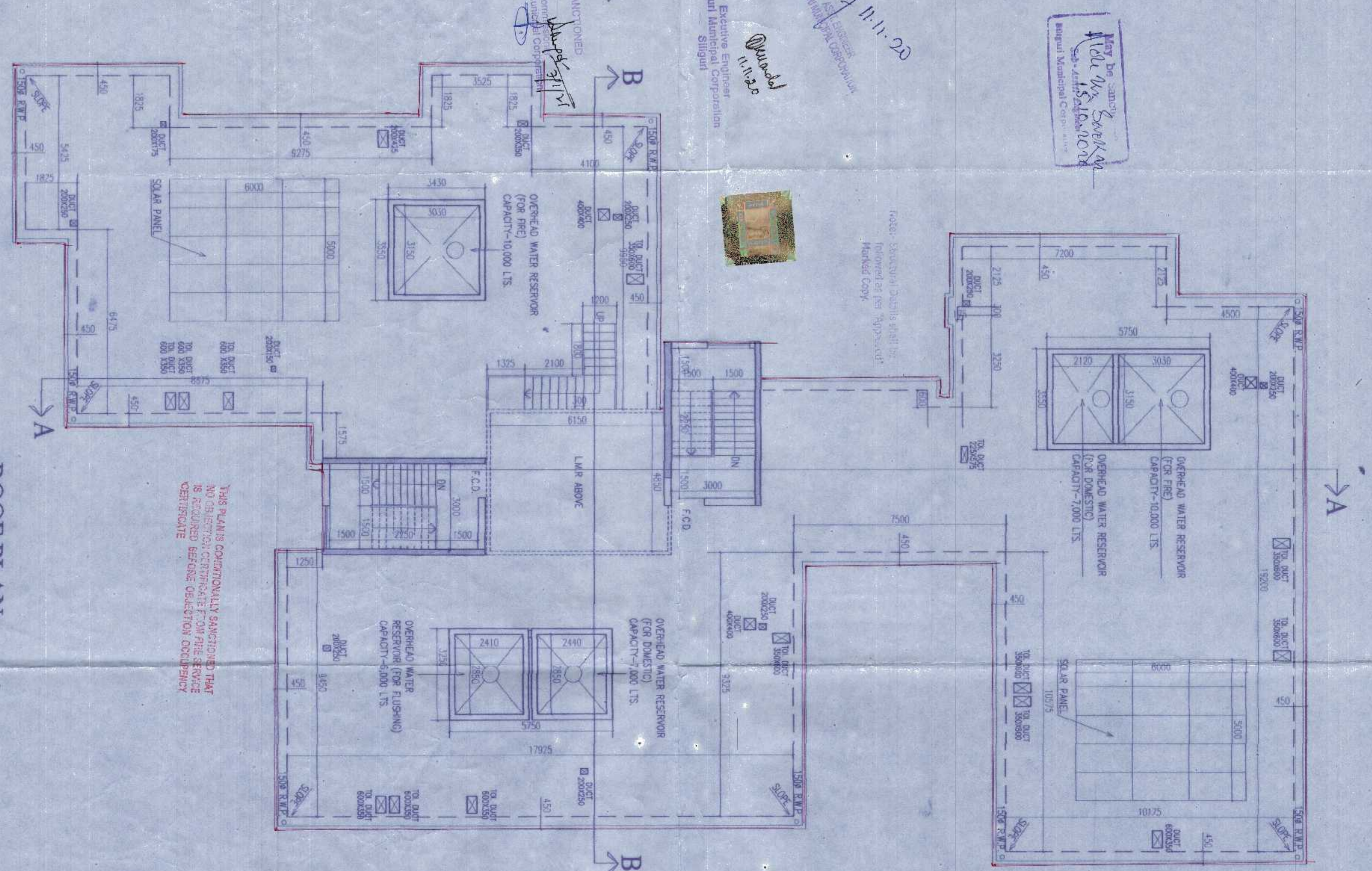
TYPICAL 3RD, 7TH, 9TH & 11TH FLOOR PLAN (RESIDENTIAL)
