Sub: Extension of Time for Development of Avidipta Phase II

Dear Sir.

In reference to the letter no. BP/WBHB/01/0001 dated 12.10.2018 and Agreement dated 8th July, 2009 between yourselves and Bengal Peerless Housing Development Company Limited and further Agreement for Extension of Time dated 24.09.2015 (Clause 01), it was stated that the Company shall complete the ongoing complex on 9.44 acres of land within July, 2017 and shall complete the proposed complex on 3.23 acres of land within 05 years from the date of execution of the Agreement subject to force majeure and other reasons beyond the direct control of the Company.

In this connection our Company have already completed the ongoing Complex on 9.44 acres of land being Avidipta Phase I and partial occupancy certificate dated 5th July, 2016 from Kolkata Municipal Corporation have already been obtained.

We would also like to inform that the sanction plan of Phase II of the project to be constructed on about 3.23 acres of land being Avidipta Phase II was obtained on 11.01.2017. The number of towers to be constructed as per the aforementioned sanction plan will be 1-29 storied for MIG, 1-35 storied for LIG and 2-47 storied for HIG along with a common basement, upto 5th Floor.
