"**DECLARANT**" (which term or expression unless repugnant and/or contrary to the context shall be deemed to include his successor-in-office appointed by virtue of this indenture of declaration, administrator, official Trustee who may be appointed by any competent Court of Law) of the **ONE PART**:

AND

SHRI DIPPAMAN SAMANTA, son of Shri Ajit Kumar Samanta, aged about 40 years, by faith – Hindu, by occupation – Service Holder, at present residing at 82/2, Raja Ram Mohan Roy Road, Police Station previously Thakurpukur now Haridevpur, Kolkata – 700008, (which term or expression unless repugnant and/or contrary to the context shall be deemed to include his successor-in-office to be appointed by him by virtue of indenture of his declaration, administrator, official trustee who may be appointed by any competent Court of Law) of the **OTHER PART WITNESSETH**:

JEW THAKUR.

- 2. That by virtue of the Order dated 14.07.1986 in the Misc. Case

 No. 19 of 1986 passed by the Learned District Judge, 24
 Parganas (South), having his Court at Alipore, Kolkata, the

 decree mentioned above was confirmed.
- 3. That the sole Sebait of SREE SREE MADAN MOHAN JEW THAKUR namely Sudhir Kumar Samanta and his successor-in-office was empowered to appoint the Sebait/Sebaits of SREE SREE MADAN MOHAN JEW THAKUR as the successor/successor-in-office.
- 4. That the declarant herein is 79 years old and as such, he thinks that it is prudent and necessary to select and appoint his successor/successors-in-office the next sebait/sebaits of SREE SREE MADAN MOHAN JEW THAKUR enshrined in the temple at 70, Raja Ram Mohan Roy Road, Kolkata 700008, by virtue of the decree passed in the above said Title Suit No. 296 of 1940 and as such, he by this declaration to appoints SRI DIPPAMAN SAMANTA, his only son the sole Sebait of the deity.
- 5. That in view of the above the appointee of the declarant will act in the status of the sole Sebait of SREE SREE MADAN MOHAN

JEW THAKUR by stepping in the shoes of the declarant herein, and he will appoint his successor-in-office by virtue of his power conferred upon him as per the provisions incorporated in Clause No. 4 of the Solenama being the part and parcel of the decree in Title Suit No. 296 of 1940, confirmed by the order of the Learned District Judge at Alipore, 24-Parganas (South) on the following terms and conditions:-

- a) Shri Dippaman Samanta, son of Shri Ajit Kumar Samanta, aged about 40 years, the declarant herein, by faith Hindu, by occupation Service Holder, will be the next Sebait upon the demise of the declarant and will perform and discharge his duties as sole Sebait in the same manner the declarant has been discharging in accordance with the direction of the above decree and the provisions hereinafter giving.
- b) If the appointed Sebait predeceases the declarant the Administrator General, Government of West Bengal will step in the shoes of the declarant herein and will discharge the duties of the sole Sebait as stated in the para 1 above and/or according to the direction of the Learned Competent Court of Law to which the matter may be referred for having the reference case disposed of recording

necessary direction as the Court may deem fit and proper in this regard.

It is further stated that next Sebait appointed by the declarant will have the power to discharge his duties provided he observes the following directions:-

- i) He will appoint the Priest (Purohit) after the demise of the present Priest (Purohit) or earlier removal of him who will carry on the "NITYA SEBA PUJA" of SHRI SHRI MADAN MOHAN JEW THAKUR and if he falls sick he will arrange the Nitya Seba by some other Priest according to his choice.
- The offerings to SREE SREE MADAN MOHAN JEW
 THAKUR in cash or kind will be collected by the
 Sebait or his appointed person and after giving the
 traditional dues in cash or kind out of said offerings
 to the Priest according to the normal practice the
 residual offerings will be utilized for "DARIDRA
 NARAYAN SEBA" and accumulate the residue after
 incurring the expenses from the collection will be
 kept in the fund of SREE SREE MADAN MOHAN
 JEW THAKUR in hand or at Bank under the account
 opened to be opened in the name of SREE SREE

MADAN MOHAN JEW THAKUR but not in the name of the Sebait appointed herein and the said account/s will be operated by the said Sebait. The Sebait will be at liberty to spend the money in hand incurring the expenses for "DARIDRA NARAYAN SEBA".

iii) The rent and incoming money out of the assets of SREE SREE MADAN MOHAN JEW THAKUR will be collected by said Sebait himself or through his appointed person and proper Books of Account will be maintained in respect of the income and expenditure on account of the maintenance of temple, seva puja of the deity and extension/renovation of the temple according to the availability of the fund in this respect will be effected by him on the basis of proper vouchers for expenses. The Sebait may take necessary advice and/or help from such outside person or persons as is/are interested in the religious aspects of the deity as the said Sebait will think to be fit and proper in the interest of keeping up the intention and desire suiting the very object of the TRUSTEE OR ARPANNAMA as mentioned in the order of the Learned Court in Misc. Case No. 19 of 1986 in

respect of the assets being both movable and immovable properties of SREE SREE MADAN MOHAN JEW THAKUR.

- iv) The Sebait will not turn into sceptic about the existence of God with the influence of the philosophy of any person or order. In the eventuality of his turning into non-believer of the existence of God he must appoint some other person of his choice having faith in God to the post of Sebait of SREE SREE MADAN MOHAN JEW THAKUR.
- v) The Sebait must be in his normal sense and possess normal frasightness for the maintenance of the assets of the estate of SREE SREE MADAN MOHAN JEW THAKUR.
- vi) If the Sebait falls sick and/or becomes incapacitated he will appoint a Sebait in his place according to his choice.
- vii) The person who will act as Sebait under this indenture according to the above scheme will be allowed to appoint his next Sebait according to his choice keeping in view the desire of the declarant

herein.

- viii) The declarant desires that after the demise of the person to be chosen for Sebaitship should be appointed Sebait of SREE SREE MADAN MOHAN JEW THAKUR to act as sole Sebait.
- ix) If the Sebait finds no person to be suitable for discharging the duties of Sebait after him he will hand over the estate to the Administrator General, Government of West Bengal for the administration of the estate of SREE SREE MADAN MOHAN JEW THAKUR within the ambit of his power in this regard under the provision of relevant statute and/or Court's direction.
