I, Satish Kumar Bagaria promoter of the proposed project authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:




That I Satish Kumar Bagaria (Promoter) have a legal title to the land on which the development of the proposed project is to be carried out.

- That the time period within which the project shall be completed by promoter is Satish Kumar Bagaria.

That promoter shall take all pending approvals on time, from the competent authority.
