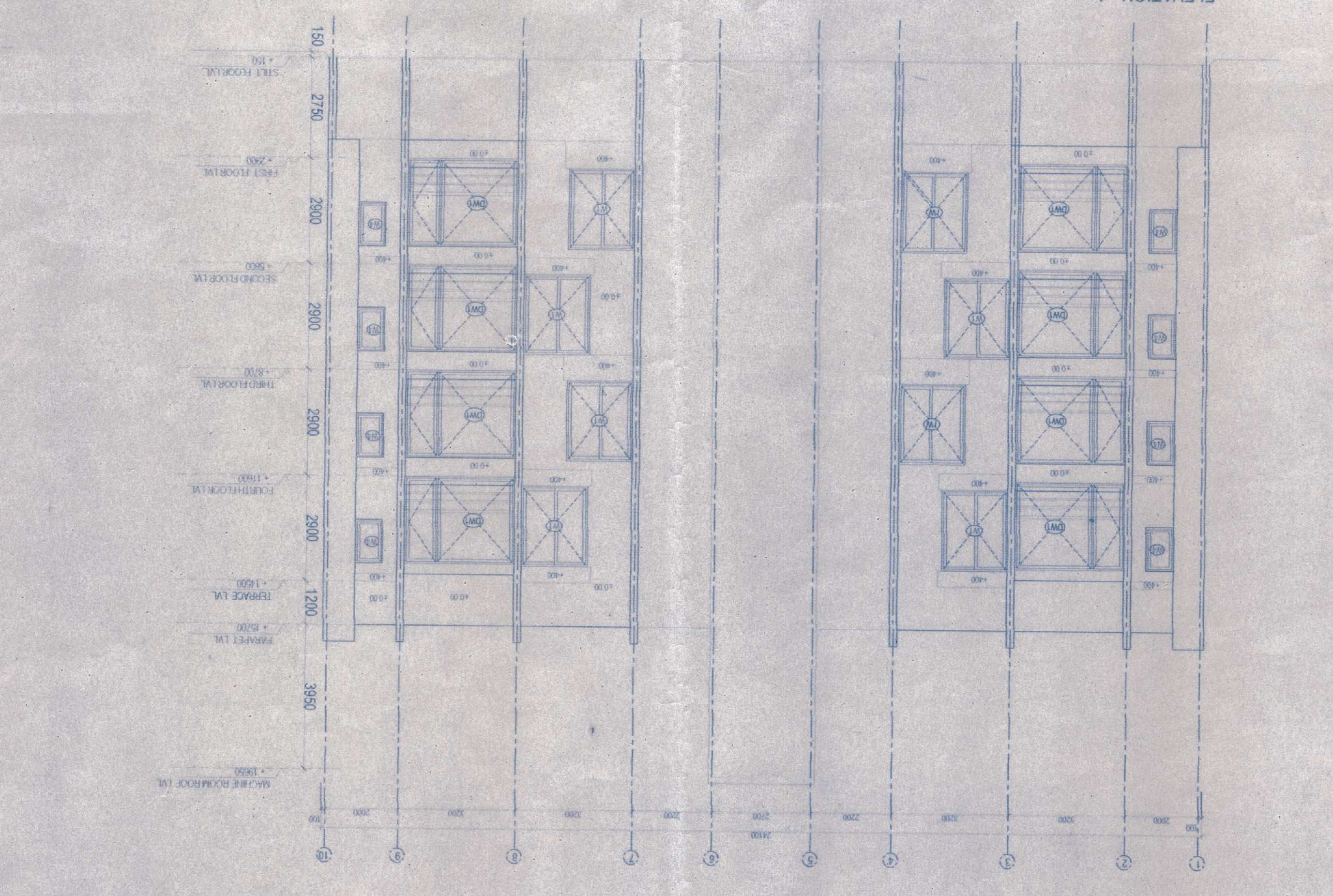
SECTION Y-Y
