THIS DEED OF APPOINTMENT OF NEW TRUSTEE is made this
day of 6 One Thousand Nine Hundred and Fifty-four
RISHU CHANDRA KHAN son of Gopijeeban Khan deceased (hereinafter
called the Continuing Trustee) of the First Part GANESH CHANDRA
KHAN and KARTICK CHANDRA KHAN both sons of Gopijeeban Khan
deceased (hereinafter called the Retiring Trustees) of the SECOND
PART and SRIMATI LILA KHAN wife of the said Rishu Chandra Khan
(hereinafter called the New Trustee) of the Third Part all
residing at Wankundu in the District of Hooghly Hindu landholders
WHEREAS the parties hereto of the first and second parts
are the Trustees under an Indenture of Trust dated the 26th June
1946 hereinafter recited AND WHEREAS by the said Indenture of
Trust dated the 26th June 1946 between Jogendra Chandra Khan since
deceased grandfather of the Continuing and Retiring Trustees
thereinafter and hereinafter called the Settler of the one part
and the said Ganesh Chandra Khan Kartick Chandra Khan and Rishu
Chandra Khan thereinafter and hereinafter referred to as the
Trustees of the other part and registered at the Calcutta Registry

Office in Book I Volume 83 Pages 112 to 154 Being No. 2363 for the year 1946 the said Settlor granted conveyed transferred and -- assigned unto the said Trustees ALL THOSE the properties described in the Schedules 'A' thereunder written (hereinafter and hereinafter referred to as the trust properties) TO HAVE AND TO HOLD the -- said trust properties and every one of them unto and to the use of the said Trustees upon and subject to the trusts provisions declarations hereinafter declared and for the ends intents and purposes hereinafter expressed of and concerning the said trusts and objects hereinafter stated AND WHEREAS the Trustees accepted the trusts contained in the Indentures of 26th June 1946 and took upon themselves the burden and obligation of administering the trust estate in -- terms thereof. AND WHEREAS the Settlor Jogendra Chandra Khan died on the 1st day of July 1946 AND WHEREAS in exercise of the powers -- conferred on the Trustees by the said Deed of Trust dated the 26th June 1946 the Trustees had divided the trust properties into three equal parts or shares in terms of the said Deed of Trust and had prepared and signed three separate lists marked "KA", "KHA" and "GA" AND WHEREAS by an Indenture made on and bearing date the 15th day of November 1954 the Trustees declared that they were holding the said properties in list 'Ka', 'Kha' and 'Ga' respectively as Trustees in terms of the said Deed of Trust dated the 26th day of June 1946 and a true copy of such lists 'Ka', 'Kha' and 'Ga' is set out in the Schedule thereunder AND WHEREAS by the said hereinbefore in part recited Indenture of Trust dated the 26th day of June 1946 it was declared that if any of the Trustees amongst the grandsons of the Settlor shall die or desire to be discharged -- from the office of Trustee under the said Indenture of Trust or refuse or decline or become incapable to act in the execution of the said trusts then and in such case the eldest male child for the time being of such Trustee shall become the Trustee in his -- place and stead failing which it shall be lawful for the surviving Trustees or Trustee of the said Indenture of Trust for the time

being to appoint any other persons or person to be Trustee or Trustees in the place and stead of the Trustee or Trustees so dying or desirous of being discharged or refusing or declining or becoming incapable to act as aforesaid and in making such appointment as aforesaid preference shall in the first instance be given to the mothers of the great grandsons of the settlor provided the great grandsons are alive and failing them to honest religiously minded persons of outstanding ability and holding a good position in society PROVIDED ALWAYS that the number of Trustees shall never be less than two at a time AND WHEREAS no male child of the said Trustees has attained majority or age of discretion they all being mere children AND WHEREAS the said Ganesh Chandra Khan and Kartick Chandra Khan are desirous of being discharged from the office of the Trustees in respect of the properties set out in the list 'Ga' hereinbefore mentioned and a copy of such list is also set out in the Schedule hereunder written AND WHEREAS the Trustees are desirous of appointing the said Smt. Lila Khan as a Trustee in place and stead of the said Retiring Trustees Ganesh Chandra Khan and Kartick Chandra Khan, NOW THIS INDENTURE WITNESSETH that they the said Ganesh Chandra Khan and Kartick Chandra Khan do and each of them doth hereby declare that they are not desirous of continuing as Trustees and they do hereby retire from the trusts of the said Indenture of Trust dated the 26th day of June 1946 so far as relate to the separate properties set out in the said list "Ga" in the schedule hereunder written AND THIS INDENTURE FURTHER WITNESSETH that they the said Continuing Trustee Bishni Chandra Khan and the Retiring Trustees Ganesh Chandra Khan and Kartick Chandra Khan do and each of them doth in exercise of the power for that purpose contained in the said Indenture of Trust dated 26th June 1946 and of all other powers them thereunto enabling hereby nominate appoint and constitute the said Smt. Lila Khan with her consent signified by her joining in and executing these presents to be the Trustee



of the said Indenture of Trust to carry on jointly with the continuing Trustee Bishnu Chandra Khan the trusts of the said Indenture of 26th June 1946 so far as relate to the separate properties set out in the said list 'Ga' and also in the Schedule hereunder written AND THIS INDENTURE FURTHER WITNESSETH that they the said Continuing Trustee Bishnu Chandra Khan and the Retiring Trustees Ganesh Chandra Khan and Kartic Chandra Khan do and each of them doth grant transfer and assign unto the New Trustee Ms. Lila Khan ALL THOSE the trust properties set out in the Schedule hereunder written TO HAVE AND TO HOLD the same unto the said New Trustee jointly with the Continuing Trustee Bishnu Chandra Khan upon the trusts and subject to the provisions on which the same ought to be held by virtue of the said Indenture of Trust dated the 26th day of June 1946 AND the said Trustees do and each of them doth hereby covenant with the New Trustee that they had not done or knowingly omitted or suffered or been party or privy to any act deed matter or thing whereby the premises or any part thereof are is can or may be incumbered charged or prejudicially affected in anywise whatsoever or whereby they are prevented from granting transferring and assigning the same or any part thereof respectively in the manner aforesaid.

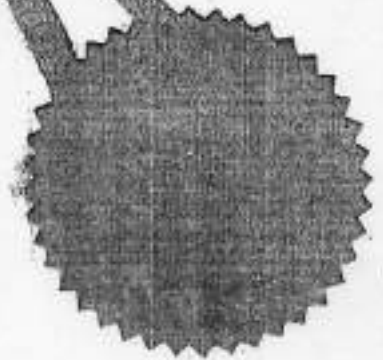

negligence or default and it shall be lawful for every trustee of these presents out of the moneys which shall come into his hands by virtue of the said trust aforesaid to reimburse himself and to allow his co-trustees or co-trustees all reasonable costs, charges and expenses which he or they respectively shall sustain or be put to in the execution of the aforesaid trusts or in anywise relating thereto and it is further agreed and declared that all the trust funds, securities, moneys and the title deeds relating to the said properties shall remain in the joint custody of the trustees -- abovenamed And it is declared that after the death of the Settlor in case of any dispute or difference of opinion between the said -- trustees regarding the management of the trust properties or the trusts of this Indenture or any matter in anywise relating thereto the opinion of the majority of the trustees for the time being shall prevail and be binding on all the trustees and be acted upon and in case the trustees for the time being are equally divided in their opinion the opinion of the group which shall include the eldest living member of the Settlor's family shall prevail and be acted upon And further if there be a difference of opinion among the trustees regarding the three equal divisions of the trust properties such difference shall not be decided by the majority of the trustees but shall be settled by reference to arbitration -- under the provision of law of Arbitration of British India each party to the difference nominating his arbitrator if they can not agree upon a single arbitrator And it is expressly declared that till division of the trust properties in three equal parts the surplus income thereof after payment of all necessary and usual outgoings shall be paid in equal shares after the death of the Settlor to his three grandsons.

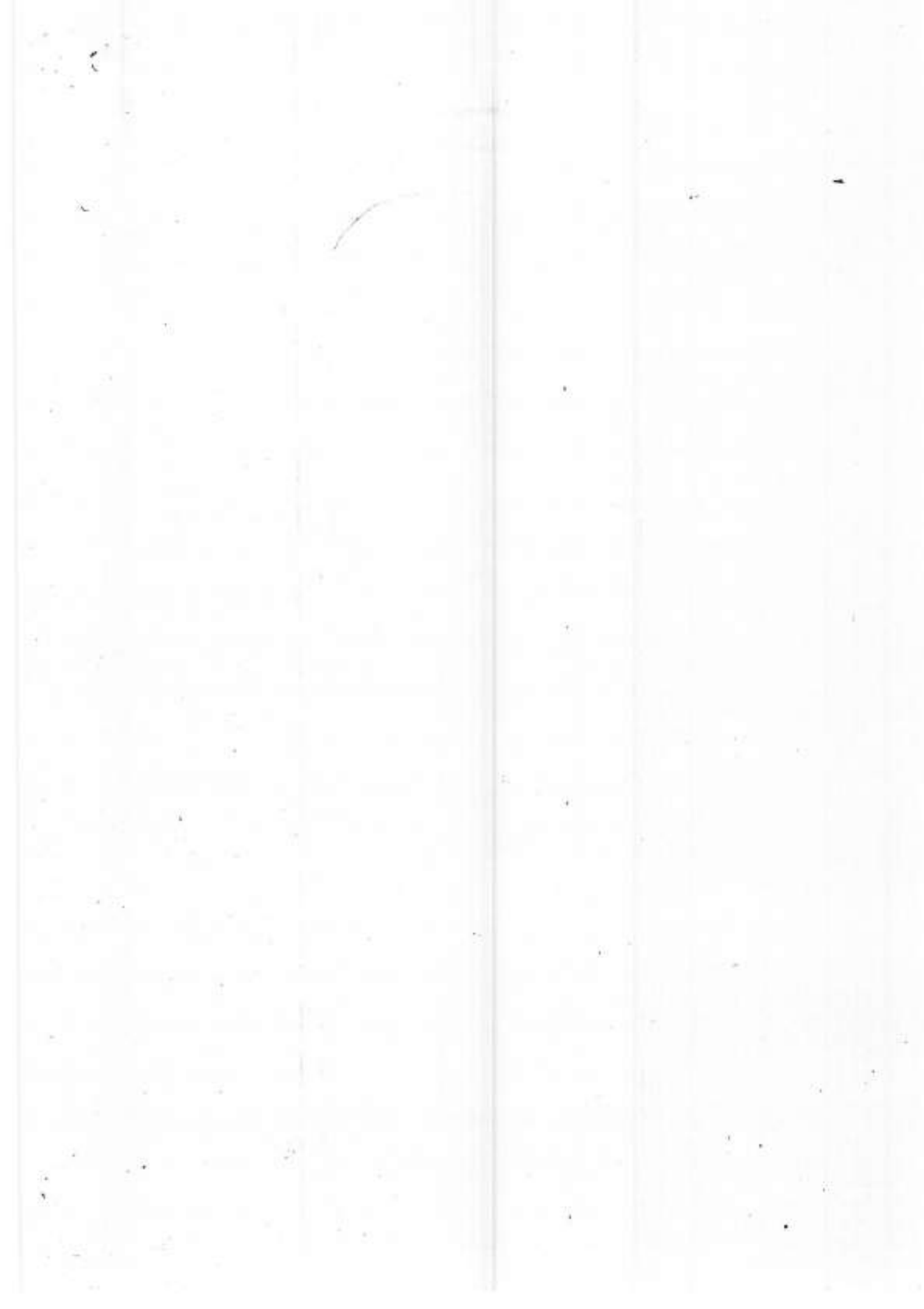

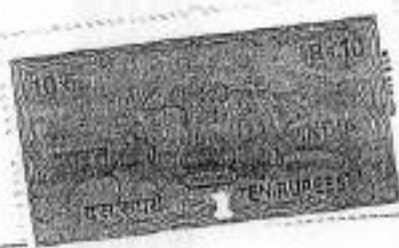
