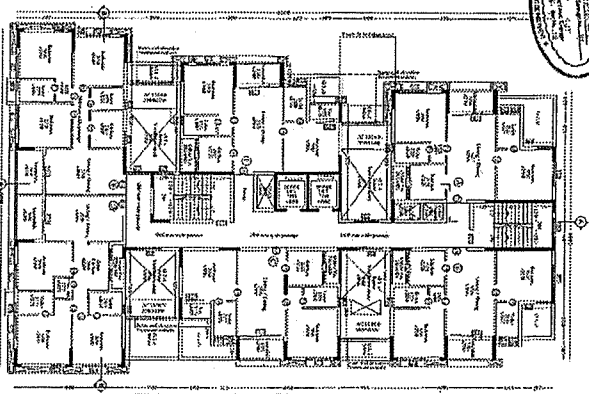
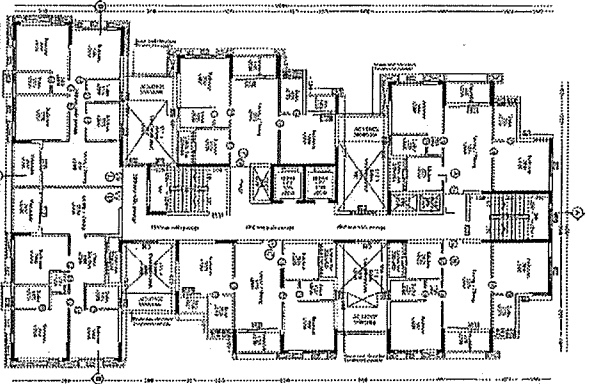


1ST FLOOR PLAN

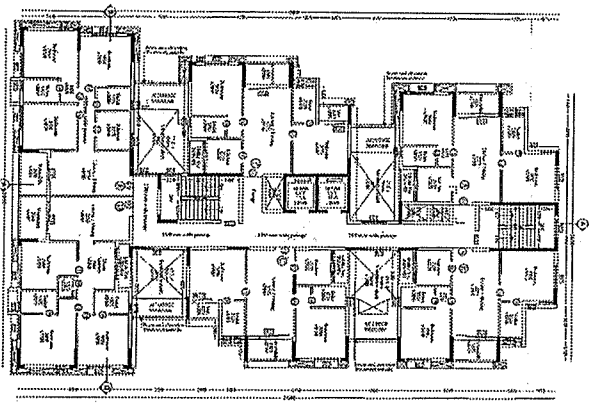

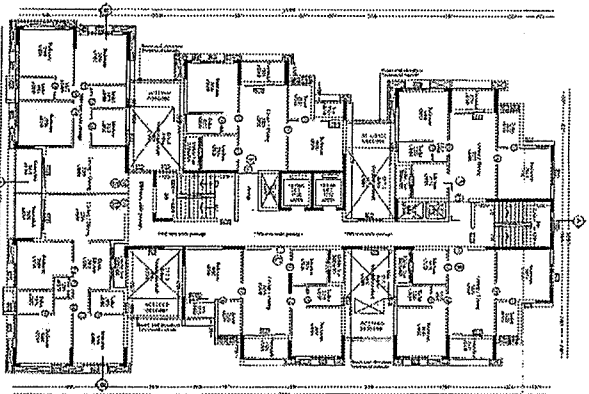
2ND FLOOR PLAN

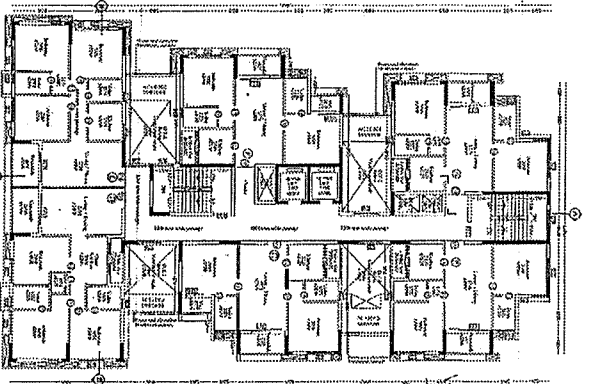
3RD FLOOR PLAN
