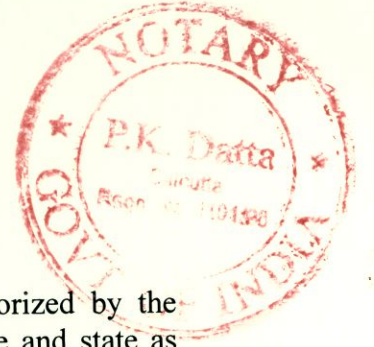

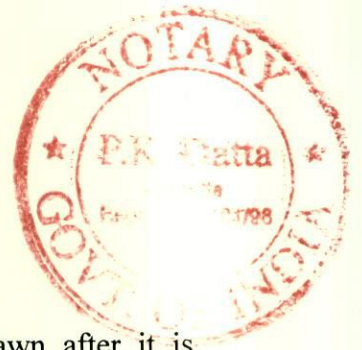

That the time period within which the project shall be completed by ~~me~~/promoter are for Oceania (Towe-1M), Marina (Tower-1L), Lagoon (Tower-1K), Islet (Tower-1J), Harbour (Tower-1H), Promenade (Tower-1N), Stream (Tower-1R), Ripple (Tower-1Q) September, 2021 and for Harmony (Tower-2A & 2B) is August, 2020.
4.
