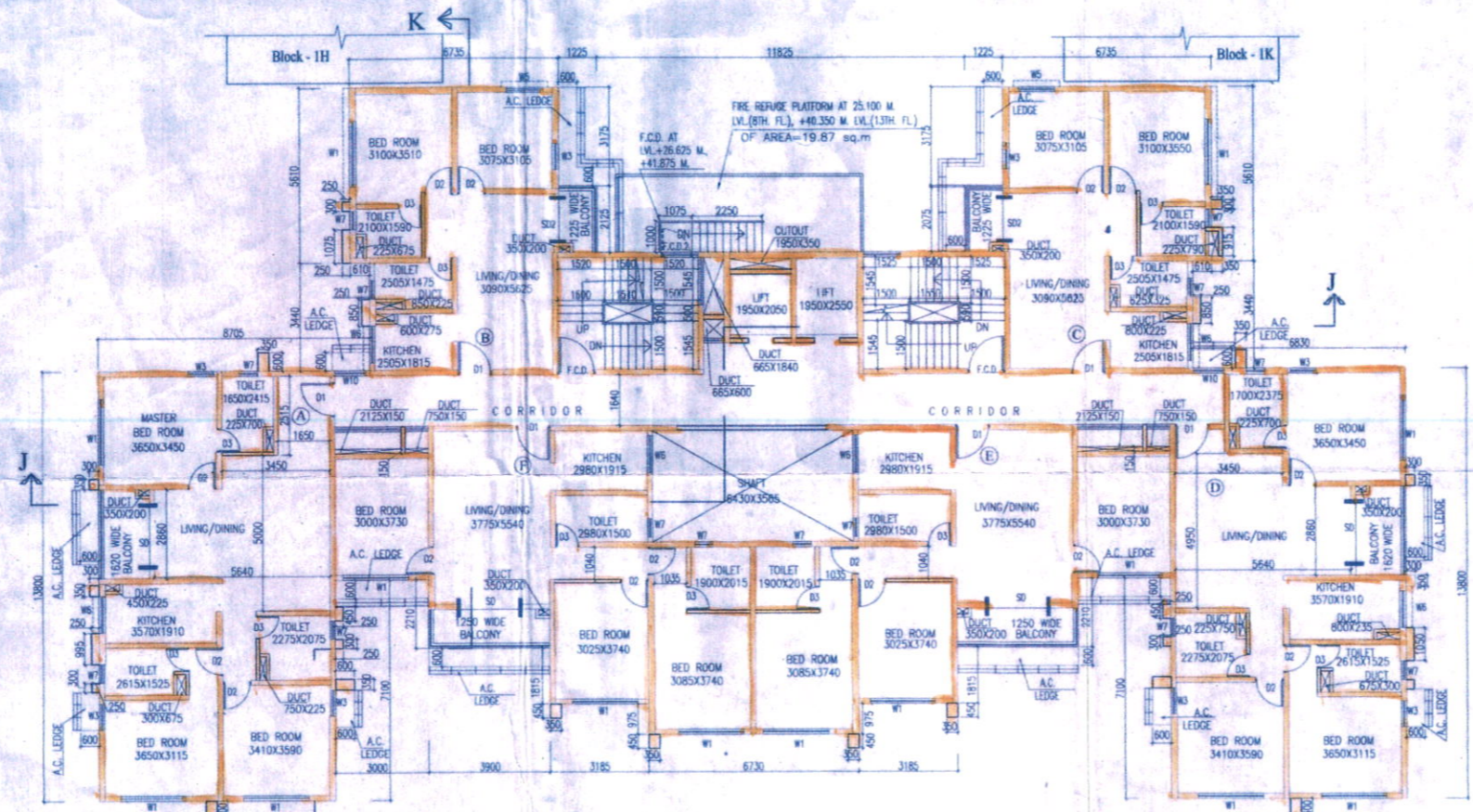


TYPICAL FLOOR PLAN (17TH - 22ND)
