- 5.1.3 **Record of Rights of Vendor:** The Vendor got her name recorded in L.R. Khatian No.507 of the Land Reforms Settlement in respect of land measuring 20 (twenty) decimal, more or less, comprised in the First Purchased Land and the Second Purchased Land (**Mother Property**).




