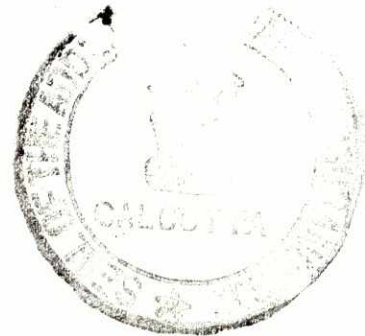

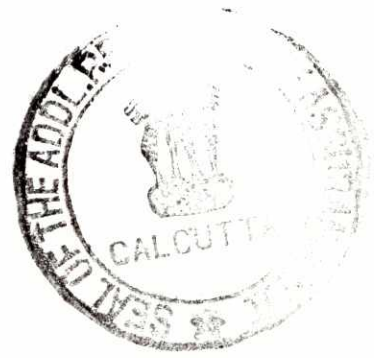

- 5.1.2 **Second Purchase by Vendor:** By a Deed of Sale in Bengali Language (*Kobala*) dated 13th July, 1966, registered in the Office of the Sub-Registrar, Cossipore Dum Dum, in Book No.I, Volume No. 94, at Pages 99 to 101, being Deed No.6429 for the year 1966, the Vendor purchased from Tufani Bibi land measuring 11.50 (eleven point five zero) decimal, more or less, being a portion of C.S. *Dag* No.609 corresponding to R.S. *Dag* No.639, recorded in C.S. *Khatian* No.43, *Mouza* Raigachi, J.L. No. 12, Police Station Rajarhat, District North 24 Parganas, for the consideration mentioned therein (**Second Purchased Land**).





- 5.1.3 **Record of Rights of Vendor:** The Vendor got her name recorded in L.R. *Khatian* No.507 of the Land Reforms Settlement in respect of land measuring 20 (twenty) decimal, more or less, comprised in the First Purchased Land and the Second Purchased Land (**Mother Property**).
- 5.1.4 **Absolute Ownership of Vendor:** In the abovementioned circumstances, the Vendor has become the sole and absolute owner of the Mother Property and consequently, that of the Said Property which is a portion of and comprised in the Mother Property.
- 5.2 **Representations, Warranties and Covenants by Vendor:** The Vendor represents, warrants and covenants as follows:

5.2.10 **No Bar by Court Order or Statutory Authority:** There is no order of Court or any other statutory authority prohibiting the Vendor from selling, transferring and/or alienating the Said Property or any part thereof.

6. Basic Understanding

- 8.1.4 **Together with All Other Appurtenances:** together with all other rights the Vendor has in the Said Property and all other appurtenances including but not limited to customary and other rights of easements for beneficial use of the Said Property.
- 8.2 **Subject to:** The transfer being effected by this Conveyance is subject to:

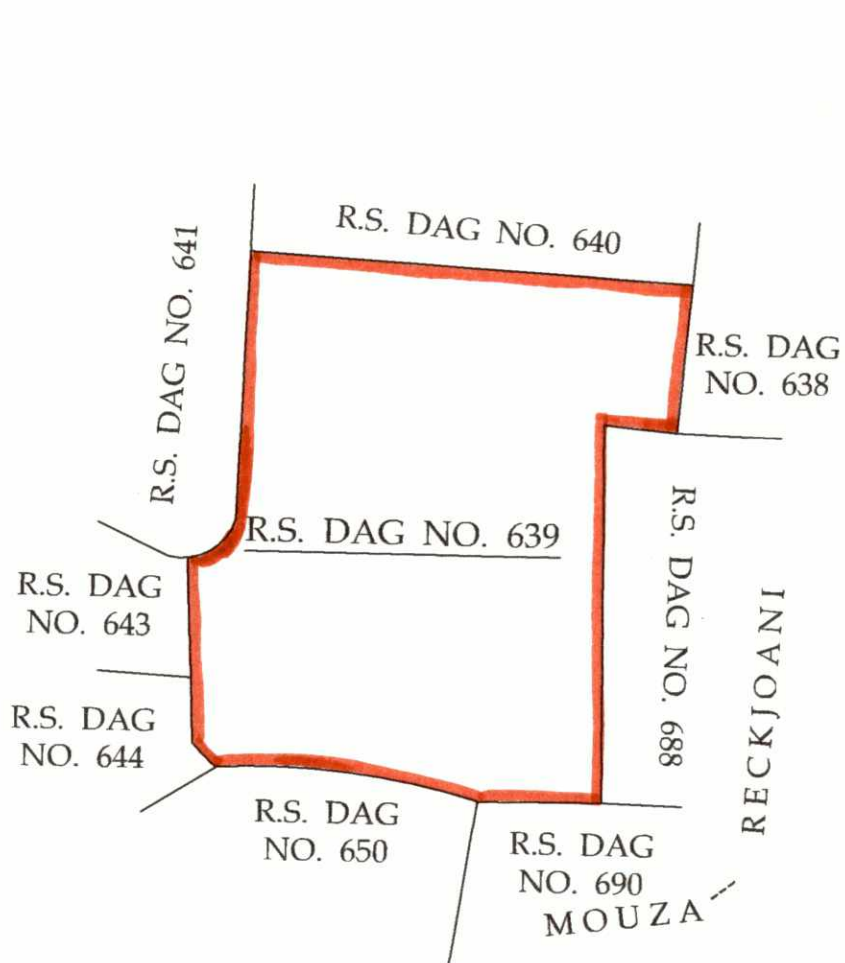

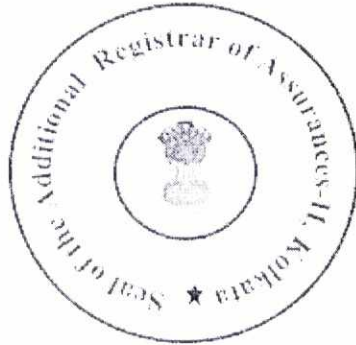
